Sgt. Bartuch,

Your email was forwarded to me over the weekend. I can set up a time to talk tomorrow, Tuesday, if it is convenient for you but I am not sure how much help we can be.

I understand you have already reached out to NPR and our partners before about accessing the Oath Keepers data. That is something like them that we cannot share, even less so now that you have an independent body there in Chicago looking into this issue. I would note that as we understand it, the Anti-Defamation League has provided you with names, in August 2022, although we do not know if they are the same as our names. They would not disclose them to us for the same reason we are not disclosing them.

I am copying our co-founder Drew Sullivan on this email, let us know if your concerns go beyond obtaining the list and I can hop on a call with you tomorrow if you are still interested.
