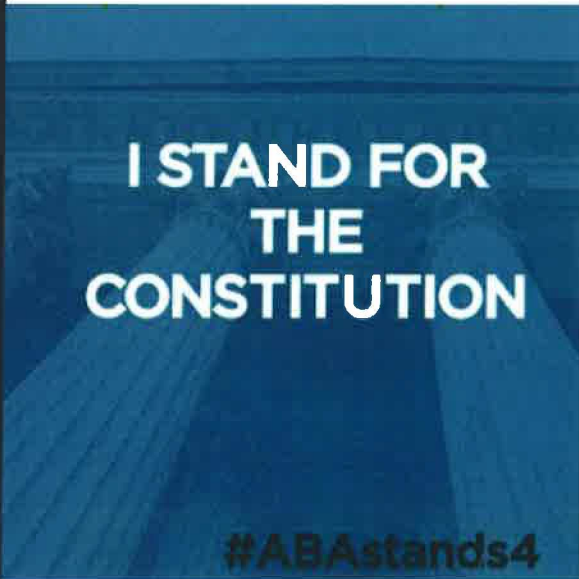

The ABA's House of Delegates approved a resolution recommending disarming American citizens based on accusations of "hate crimes" and being a threat, [the American Bar Association announced Tuesday](#). Despite due process concerns raised by some who still view the Constitution as an impediment to total and arbitrary "progressive" rule, [Resolution 118B](#) passed by one vote.

While the resolution calls for "documented evidence," that's an arbitrary term and has no bearing on the quality of the evidence or of its admissibility. What is to be "verifiable" is a "procedure to ensure surrender of guns and ammunition pursuant to a restraining order" and a means to report resulting restraining orders to state and federal authorities to preclude the accused from buying guns and ammunition.

"Gun violence restraining orders are a modest common-sense reform to address at least one piece" Estelle Rogers, a "progressive" (naturally) member of the Civil Rights and Social Justice (!) faction declared, adding the other requisite gun-grabber narrative talking points that "the right to keep and bear arms isn't absolute."

Connecticut Bar Association President and gun infringement activist Monte Frank then made the obligatory reference to Newtown as a reason to support the measure, ignoring the inconvenient truth that his state's restraining order edict would not have applied to the lawful owner of the reportedly stolen guns.

Joined in opposition by the Law Student Division, Vermont attorney Peter Langrock tried to steer things back to the Constitution, warning "such orders raise First Amendment concerns because they could target people based on speech, including statements on social media. Langrock also said the [ex parte orders](#) raise 14th Amendment due process concerns, and gun seizures based on such orders raise Fourth Amendment concerns."

What's clear is there is a dominant faction of "progressive" lawyers within the ABA leadership - officers of the court - for whom the Constitution is something to be twisted, subverted and ignored as suits their agenda. Recalling that for "progressives," every day is Opposite Day, is it any wonder that "innocent until proven guilty" has been reversed, and that demands are being made to deny fundamental natural rights of citizens not even charged with a crime, let alone convicted of one?

Attorney says FBI violating privacy, due process and equal protection by secretly using personal information from the ATF Form 4473 for the unauthorized purpose of checking gun buyers against the Terror Screening Database.

"FBI admits unauthorized program against American gun owners," attorney and policy analyst [Paloma Capanna charged](#) in an update on *Robinson vs. Sessions*, a lawsuit on civil rights violations resulting from matches on the "No-Fly List."

"The US DOJ Attorneys admitted in their Answering Brief that the FBI screens 'all' Americans seeking to lawfully purchase a firearm against the Terrorist Screening Database ("TSDB") upon submission of the ATF Form 4473," Paloma wrote, quoting:

"Since 2004, as part of its background checks for all potential firearms purchasers, the NICS has searched a file containing a list of known or suspected terrorists that is exported by the Terrorist Screening Center from the TSDB into the FBI's National Crime Information Center database."

[Back in 2015](#) then-Director James Comey testified before the Senate Judiciary

Committee and made it sound like an exception where FBI was "alerted" and "notified." Additionally, in his exchange with Sen. Chuck Grassley, he noted "There are a variety of things that we do when we are notified that someone on our known or suspected terrorist database is attempting to buy a firearm," up to and including stopping the transaction, placing a suspect under surveillance, or arrest.

We've discussed the danger of using such lists, developed in secret from undisclosed sources of unknown (to the public) reliability. We've also seen how flight denials can be based on mistakes, [as happened to the late Sen. Edward Kennedy](#). How many Americans have such resources and connections to be able to expeditiously clear matters up? We've also seen serious National Instant Check System flaws, and how "[Virtually all of those denied purchasing a gun are false positives](#)."

We've seen [Joint Terrorism Task Force triggers](#) as bafflingly all-encompassing as defending the Constitution, supporting liberty candidates and ideals, sporting such apparel or bumper stickers, paying in cash, shaving your beard, and traveling an "illogical" distance to a gun-related event. We've seen the sorry state of bureaucratic overreach and infringements devolve into the even more ridiculous, as with the Pennsylvania man placed on a watch list after regularly taking a [giant inflatable pink pig](#) to political rallies.

Those demanding gun purchases be halted because of secret lists of unknown accuracy, administered by faceless bureaucrats with unknown sympathies and motives, are essentially advocating for a police state, where fundamental rights can be denied without due process. And face it-if you were a terrorist, and were further inclined to buy a gun "legally," wouldn't a NICS denial be a pretty good indication that you've been made, and allow you to evade and respond with countermeasures?

So why do these "common sense gun safety law" advocates have an unholstered handgun at a public demonstration?

"Birmingham organization proposes changes to gun laws, named for Gate City shooting victim," [AL.com reports](#). "Frank Matthews, President of the Outcast Voters League, spoke about the proposed Sheri Williams Mandatory Gun Changes Act, named for a woman who was killed in Gate City by a stray bullet in 2013. Williams was holding her 10-day-old baby as she was shot."

That's SOP for these types. Pick a high-visibility incident that pulls at the heartstrings. The object is to get people feeling, not thinking. And naturally, none of the gun laws being proposed would have made a bit of difference in this case.

Just as naturally, the obligatory opportunistic oath-breaking politician made sure to get his mug in front of the press conference cameras. State Rep. John Rogers used the coverage to make noises about "fashion[ing] a bill that's passable." Considering what they want, that's not likely (at least until the vote in Alabama becomes overwhelmingly "progressive," something the "immigration" and "amnesty" crowd is working on).

Outcast leader Matthews could not resist showing off his big "but."

"We're not against gun rights... [but] demand accountability and responsibility of gun owners," Matthews said. Here's what he means by that:

- Mandatory gun registration- owner has registration card that lists all weapons
- No transfers unless done through a registration office
- New purchases must be picked up at registration office
- Mandatory gun safes; only registered owner will have combination
- Mandatory gun safety classes
- Open carry and concealed carry policies abolished
- Waiting period for gun purchase extended to three months to allow all paperwork to pass
- People under 21 prohibited from owning guns
- Extensive mental evaluation
- Mandatory liability insurance for firearms

- Required reporting of stolen firearms within four hours of discovery
- Ammo purchases made only for the caliber gun specified on registration

Rescues by boat in flooded communities continue in the aftermath of Hurricane Harvey.

We have current information from Alex Oakes, Oath Keepers South East Regional Assistant Coordinator and Oath Keepers Mississippi Point of Contact.

We will update the information here with changes and additions as they occur.

Alex was on the ground dispatching the Cajun Navy and Oath Keepers rescue boats. The Cajun Navy is NOT pulling out of Texas. They did come under fire during attempted robberies.

There are currently over 300 boats in the water. They are also working Lafayette, LA. Alex is currently monitoring Cajun Navy Dispatch and will be heading back.

The Texas border is closed on I-10 unless there is a boat in tow or you're in a high-water vehicle.

The Cajun Navy is taking every call they possibly can and working the list. 911 is overwhelmed.

Houston to Lafayette is under evacuation. Lake Charles is now under voluntary evacuation.

There is a FALSE REPORT that the Cajun Navy is leaving Texas. Actually, they are sending out rescue boats through the night.

The photos are from Lake Charles, LA. That was as close as they could get in their vehicles.

We will post more information as it comes in.

California 'Catch-22' on 'Assault Weapons' Evokes Fundamental Question for Gun Owners

With these plans, you can convert any worn-out old firearm into an exciting new 'assault weapon'

That's right. Just follow these simple instructions, and you can take that old junker you were about to exchange for some rock concert tickets, and turn it into the "weapon of choice" for today's streets. Even your old .22 plinker will work.

Don't show up to a gunfight in the 90's...with the technology of the 80's!

What you will need:

- One empty toilet paper roll
- Duct tape, 6 inches long
- Duct tape, 5 inches long
- Duct tape, 4 inches long
- Dowel rod, 2" diameter x 7.5"
- 2 wood screws, #6 x 2"
- 1 clothes pin

Tools:

- Screwdriver
- Hacksaw
- Drill and bits

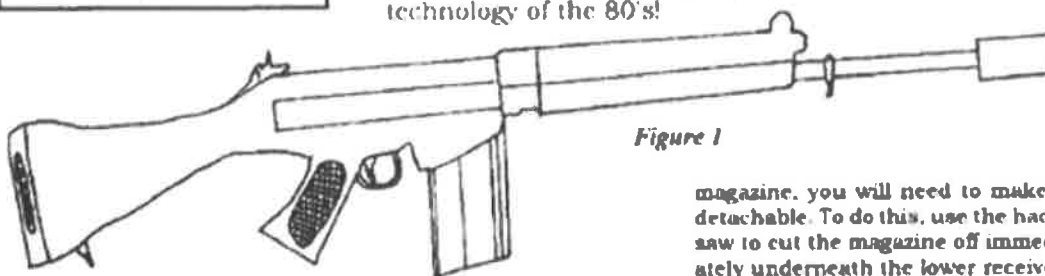

Here's What to Do...

1. Make certain your firearm is unloaded, and the action is open.
2. Use the 6" piece of duct tape to attach the flash suppressor (toilet paper roll) to the front end of the muzzle. Make certain to firmly rub the tape onto the barrel. This will avoid a loose connection.
3. Firmly secure the 2" diameter dowel rod in a vice. With the hacksaw, make several dozen criss-cross grooves on one side, then turn it over and do the same on the other side. (See Figure 1)
4. Use the drill to make two holes in one end of the dowel rod.

5. Place the two wood screws inside the holes, then place the dowel against the stock, just behind the trigger guard. Screw the pistol grip (dowel rod) onto the stock, using care not to screw into the metal of the lower receiver or the trigger assembly.
6. Next, use the 4" piece of duct tape and the clothes pin to make your bayonet lug. Wrap about 1" of the tape around one long of the pin, then wrap the rest of the tape around the barrel, just behind the flash suppressor. (Make sure the front of the clothes pin points forward, that is, in the same direction as the muzzle, otherwise, the bayonet will point backwards, towards you)
7. For those models, such as the SKS, which have a fixed

magazine, you will need to make it detachable. To do this, use the hacksaw to cut the magazine off immediately underneath the lower receiver. Then, take the remaining piece of duct tape and rip it length-wise into two separate pieces. Fold over about 1/2" on one end of each piece, then tape the magazine back onto the gun, using one strip of tape per side. When you wish to reload, simply pull back on one piece of tape, and the magazine will open.

8. Congratulations! You're done!

Warning!

Modifying your firearm as set forth in these plans may render you in violation of federal and state law. If you make such modifications, you will be considered to be in illegal possession of a Class III "Assault Weapon." The BATF has determined that mere possession of the materials with which to make an 'assault weapon' may be sufficient cause to invade your house and attack your family. Please use caution.

This was put together by some friends of mine back in the Nineties to illustrate the absurdity of what the antis were calling "assault weapons" and trying to ban.

Earlier separate bans on semiautomatic firearms demonized as "assault weapons" weren't enough for California gun-grabbers. Despite the [Roberti-Roos ban](#) on specific firearm models, and the later [Perata ban](#), a new prohibition went into effect early this year, even though the agency tasked with infringement enforcement admits compliance is impossible.

"Assembly Bill 1135 and Senate Bill 880 became effective Jan. 1 of this year and part of the new law requires those who have assault weapons to register them by Jan. 1 2018 [CBS 13](#)

[Sacramento reports](#). "But the website to do so isn't working."

UPDATE AS OF Thu Apr 27 2017 14:02:29 GMT-0400 (Eastern Daylight Time) : The ability to register an Assault Weapon pursuant to Assembly Bill 1135 and Senate Bill 880. is not yet available. Pursuant to AB 1135 and SB 880. Assault Weapon registration regulations must be effective before any registrations can take place. At this time. the regulations are still pending. however they should be effective in the very near future. Please continue to check the Bureau of Firearms website for updates.

We'll let you know when it's time to come back and surrender.

That's a screenshot from the "[Department of Justice](#)" website that not only advises the definition of "assault weapon" has been "revised" (yet again - they'll get it "right" one of these times), but that:

These bills will require that any person who, from January 1, 2001, to December 31, 2016, inclusive, lawfully possessed an assault weapon that does not have a fixed magazine, as defined in Penal Code section 30515, including those weapons with an ammunition feeding device that can be readily removed from the firearm with the use of a tool, shall register the firearm before January 1, 2018, but not before the effective date of the regulations adopted by the DOJ.

These bills will also require registrations to be submitted electronically via the Internet utilizing a public-facing application made available by the DOJ.

"Many gun owners are frustrated and say it's been months that they've been trying to register and can't," CBS 13 elaborates. They're concerned that if it's not resolved soon, there will be a mad dash to meet the deadline, only eight months away."

If they don't, and if they don't then surrender their guns, they'll become felons, prohibited persons for life, forbidden to so much as touch a gun. That's after they have their lives destroyed and "serve" prison sentences where they're at the mercy of a general prison population that includes every kind of violent, threatening and physically imposing sociopath you can imagine.

Most will comply.

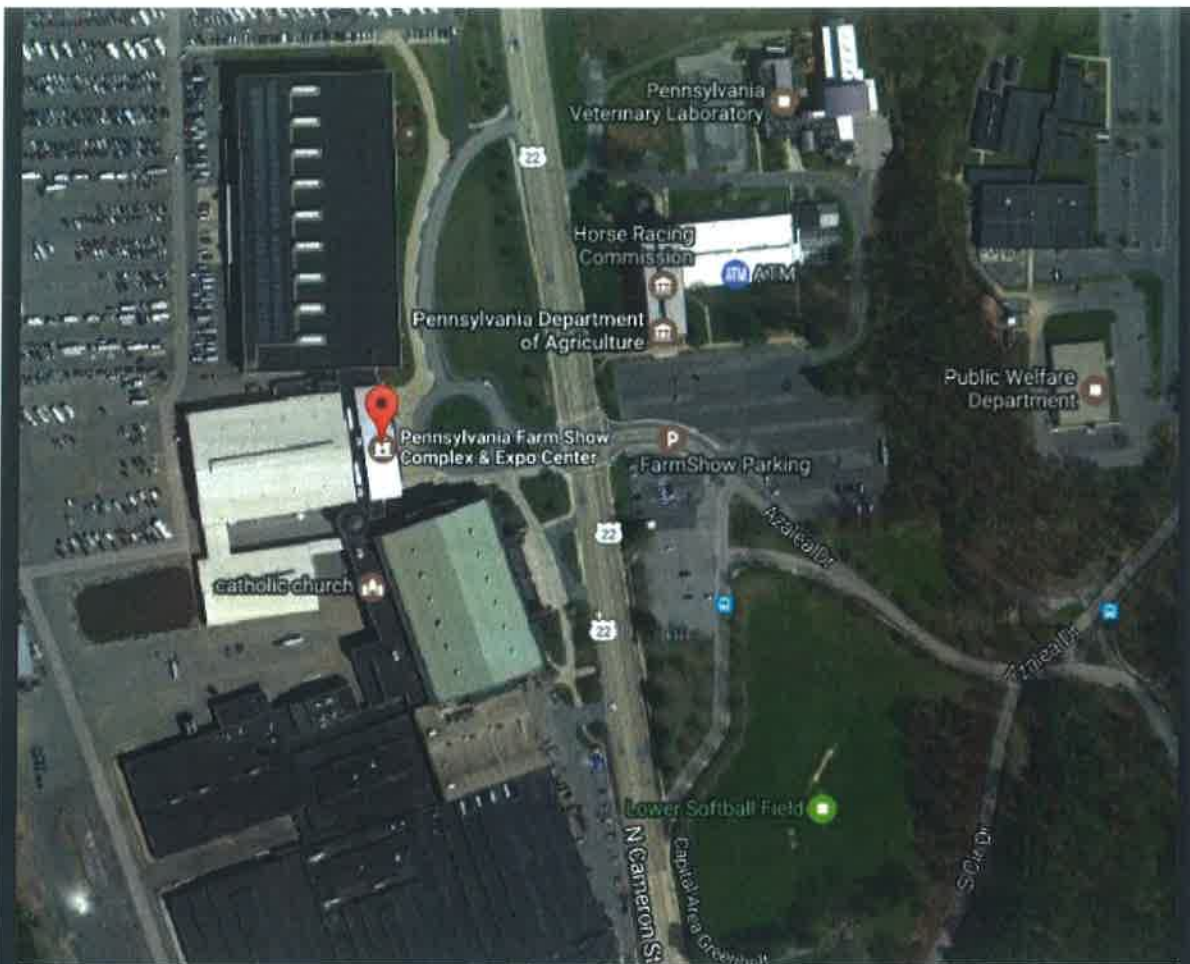

President Donald Trump will be in Harrisburg Saturday to mark his 100th day in office, hosting an event in the New Holland Arena at the Farm Show & Expo Center. Several organizations, including Antifa, are organizing anti-Trump rallies and marches to coincide with his appearance.

One of the anti-Trump events will begin around 5 p.m. near the softball field in front of the Dept. of Agriculture building on Cameron Street. In an email, organizers said that gathering will then be followed by a march beginning at 6 p.m. at the intersection of 7th and Forster. The march will proceed north on 7th Street toward the Farm Show.

A collective of regional Antifa organizations has asked its members to begin assembling on the intersection of Peffer St and Wallace St, behind the park. They anticipate that sufficient members will congregate from Antifa organizations in Pennsylvania, Maryland and New Jersey to form a march by 8:30PM. They have asked their members to "show up prepared to physically defend the march, wear black and cover your faces". They have also requested that street medics to show up prepared to provide medical treatment.

Several other organizations, including Refuse Fascism, are planning to protest the event. The total number of protesters is expected to be at least 300.



Oath Keepers has information regarding a plan by members of one of these Antifa organizations to infiltrate the Free Speech area on the West lawn of the Expo Center. We also have information that they are aware of Oath Keepers plans to attend the event with hopes of infiltrating our ranks. The intent of the planned infiltration is not clear, however it does appear that dispersion of free speech participants using fireworks and smoke canisters is a possibility.

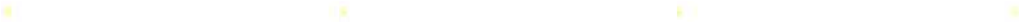

But what's the GOOD news? The GOOD news is MAINSTREAM has turned out so well, we have decided to expand it to a 4-part mini series. Given this, we will be able to release each part, one at a time, and build an audience bigger than any single, limited release.

Thus, I am happy to announce, the first episode of MAINSTREAM - *How Hollywood Movies and the New York Media Are Promoting the Globalist Agenda* will be released on Flag Day, June 14th 2017.

This episode is entitled, THE HOLLYWOOD MOVIES - Part 1. 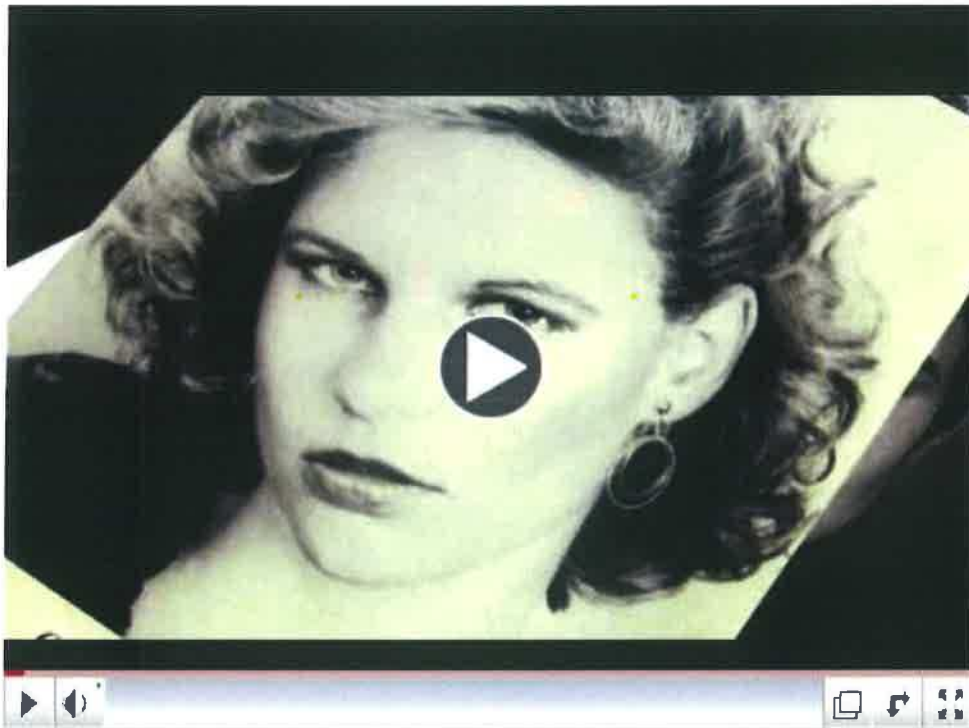

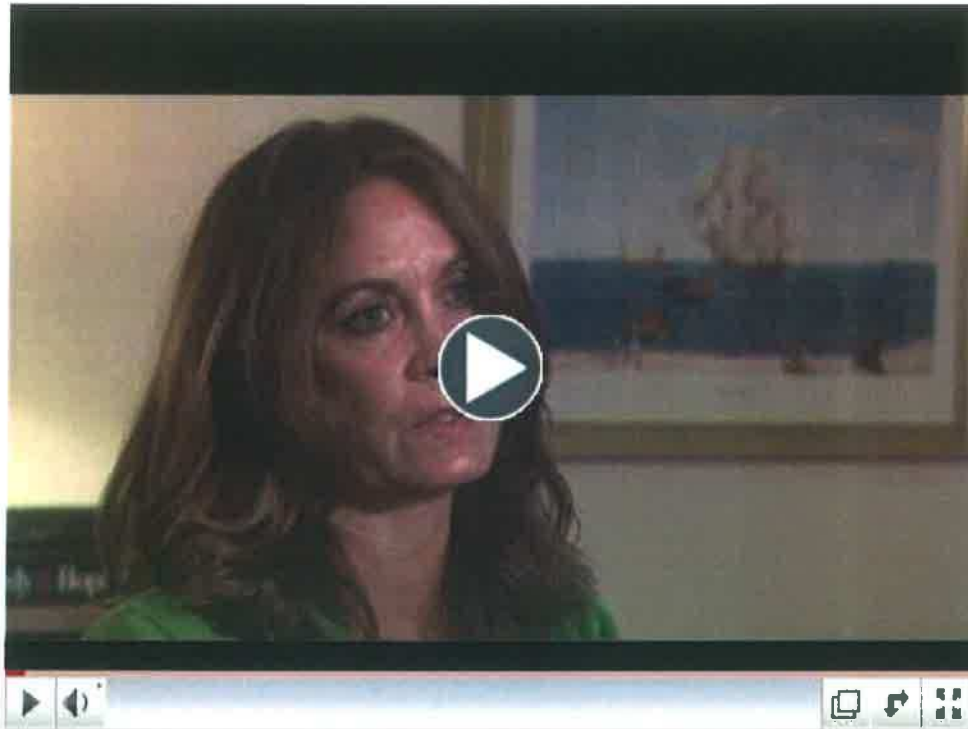

Organizers and participants in the March 4 Trump events need to understand that we can't be at all of them, and we can't guarantee their safety even at the ones we will be attending. Your safety is ultimately up to you, as the below advice makes clear.

You can see from the feature illustration above what the general public is being led to believe about Oath Keepers. It's like the Southern Poverty Law Center narrative on steroids.

Patriots who revere the Constitution are called "anti-government." [An association with bylaws](#) featured prominently in the website header that are available for anyone to see for themselves is called a "militia." That those bylaws disqualify from membership any

"person who advocates, or has been or is a member, or associated with, any organization, formal or informal, that advocates the overthrow of the government of the United States or the violation of the Constitution thereof," and any "person who advocates, or has been or is a member, or associated with, any organization, formal or informal, that advocates discrimination, violence, or hatred toward any person based upon their race, nationality, creed, or color," is never mentioned. All most Americans will ever hear about Oath Keepers is that they are right wing extremists, domestic terrorists and haters on par with Nazis and the Klan.

Correcting that record is also suppressed. The Google News feed does not include articles originated by Oath Keepers, limiting what does appear to ... well, [see for yourself](#). That's also a recurring problem I have with articles I publish in other venues that do make the news feed - only to be removed later by deliberate intervention, something [I've documented time and again](#) after noticing exclusive stories being "disappeared."

Relying on the so-called "mainstream media" to give a fair shake has proven futile. Too many liberty advocates have been burned too many times by opening up to supposedly objective reporters, only to find out later they've been presented out of context and used to advance a negative narrative.

That basically leaves two ways to get our side of the story out: Rely on supporters to share links (which is generally only done by a handful with very limited contacts, and even then not usually consistently), or spread the word in the only affordable way we can, via so-called "social media."

Come now the Plaintiffs, by and through undersigned counsel, and allege
as follows:

1. This is an action under the Freedom of Information Act, 5 U.S.C.
§ 552, for injunctive and other appropriate relief and seeking the disclosure
and release of agency records improperly withheld from Plaintiffs by the U.S.
Department of State ("DoS").

JURISDICTION AND VENUE

Read the complaint.

"Today we filed suit against the Department of State on behalf of Kent Terry and David
Codrea," Stamboulieh Law, PLLC announced Sunday. The complaint was filed due to
State's inaction on complying with a Freedom of Information Act Request submitted in
June, 2016 seeking information on correspondence, documents and the like pertaining
to Operation Fast and Furious "gunwalking" and State Department interactions with
the government of Mexico.

There are multiple reasons for filing the request, [AmmoLand Shooting Sports News reported](#) when the FOIA ([read it here](#)) was filed, primarily because it explores an area that has been left largely unresolved by official inquiries from the House Committee on Oversight and Government Reform, the Senate Judiciary Committee, and the Department of Justice Office of Inspector General. Included in the concerns:

- To corroborate if the government of Mexico was [intentionally not informed](#) of a U.S. government law enforcement operation where it was known guns were being illegally exported across its border.
- To determine if Arms Export Control Act regulations were [violated and/or ignored](#).
- To seek further information on why the then-[White House Counsel denied](#) the House Oversight Committee access to a former National Security Council official who had been given information on Gun Running Impact Teams by the former top ATF official in Phoenix associated with Fast and Furious, along with the disclaimer "You didn't get these from me."

"DoS was required to determine whether to comply with Plaintiffs' request within twenty (20) working days of receiving the request, or on or about July 29, 2016," [the complaint asserts](#). "Because DoS failed to determine whether to comply with Plaintiffs' request within the time period required by FOIA, Plaintiffs are deemed to have exhausted their administrative remedies."

Because of what appears to be deliberate indifference and stonewalling, the court is being asked to:

- "Order Defendant to conduct a search for any and all responsive records to Plaintiffs' FOIA request..."
- "Produce, by a date certain, any and all non-exempt records to Plaintiffs' FOIA request..."
- "Enjoin Defendants from continuing to withhold any and all nonexempt records..."
- "Grant Plaintiff an award of attorneys' fees and other litigation costs reasonably incurred..."
- "Grant Plaintiff such other relief as the Court deems just and proper."

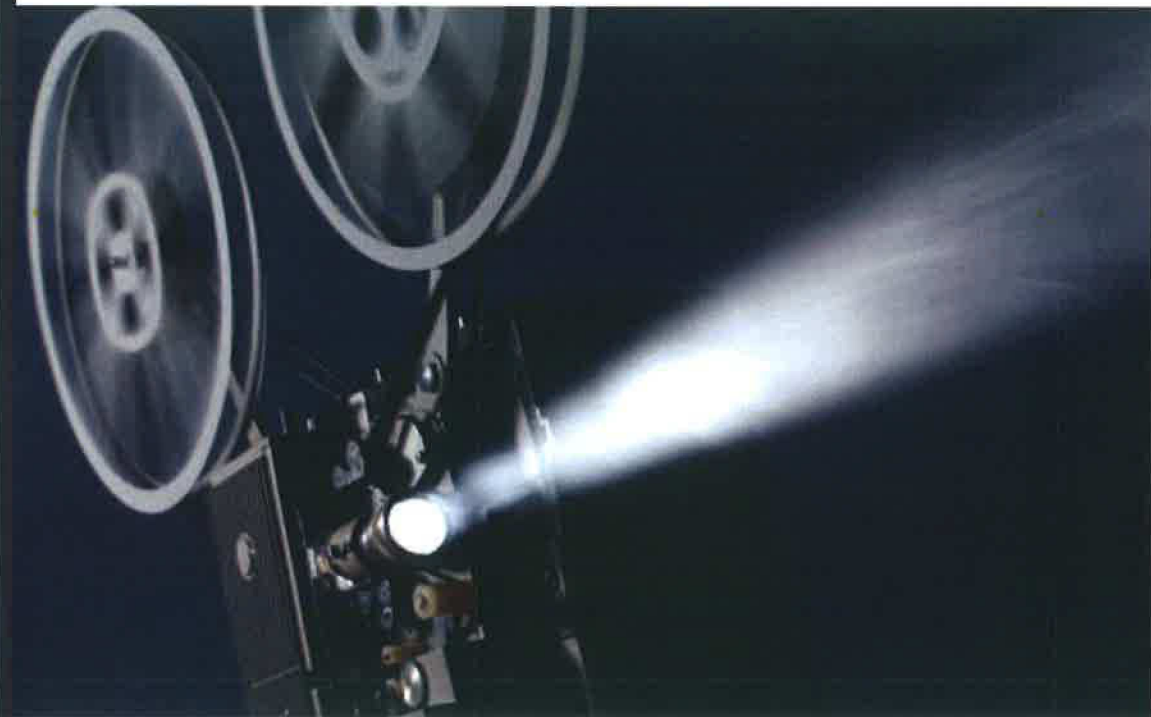

Dear MAINSTREAM Associate,

We have been making good progress on the editing of MAINSTREAM and to this end I am happy to report that we are done with 16 out of the 25 chapters of the rough-cut. If you are unfamiliar with the term "rough-cut" here is the definition:

DEFINITION: A rough-cut is the first edit of a motion picture. Its purpose is to block out the major elements of picture and sound so that there is a clear continuity to the story line. In terms of documentary films, the major elements are the narration and the interviewee dialog track. Picture may accompany the interviewees, however the interviewee dialog includes many jump cuts. All these, as well as the black picture over the narration, will be covered with b-roll picture in the "fine-cut." There is generally no music, sound FXs, transitions, titles or special FXs in a rough-cut. Also, the sound has not been leveled or mixed and there is no color, brightness or contrast correction in the rough-cut.

With this in mind, allow me to show you various chapters of the rough-cut, and you can see how MAINSTREAM - How Hollywood Movies and New York Media Are Promoting the Globalist Agenda is shaping up.
