Media Spreads Fake News with VPC Silencer Disinformation

That's a big claim VPC is making. So why doesn't the media even try to determine if it's true before expecting the public to swallow it whole?

"Study Shows Firearm Silencers Threaten Public Safety," [NJToday "reported" Monday](#) in what could better be described as a press release for the virulently anti-gun Violence Policy Center. Calling a handful of isolated anecdotes woven into an attack piece a "study" is the first bit of deception. Presenting those anecdotes and VPC's conclusion without even attempting to consult someone who might actually know what he's talking about is a good indication that the "staff reporters" are flacks fraudulently promulgating agenda politics rather than investigating and reporting in a manner consistent with any semblance of ethics or respect for canons of journalism.

That makes them disrespectful of their readers. They're also lazy. The anecdotal bullet points NJToday lists are lifted word-for-word [from the VPC presser](#).

[The "study" itself](#) consists of summaries of a handful of cherry-picked media accounts presented with the obligatory VPC charged term hyperbole, that is, terms designed to

gin up the hysteria like "white supremacist ... serial killer," and the surefire button-pusher, "anti-government militia." It's the same lazy M.O. they use when spooking the herd over "[concealed carry killers](#)," right down to substituting a patchwork of media accounts for data, all the while failing to establish causation or even relevance.

But they do include some footnotes, not that this adds any validity, considering the references are to "news" stories that may or may not have been written with the same standards "upheld" by NJToday, and to further VPC "studies." They also include some pictures to look at of old silencer ads, a graph of "legal" suppressor ownership (just to make things look scientific), and another curious list of bullet points taken from manufacturer promotional material, and from which VPC somehow draws the conclusion that the safest firearms are the ones that are least accurate!

No doubt a real study of suppressor ownership would produce similar results as [a deconstruction of VPC's concealed carry hysteria](#), that "[T]he percentage of concealed-carry permit holders who have killed someone with a firearm comes to two one-thousandths of 1 percent."

Michigan Adoption Rules Demonstrates Gun-Grabber Preference for Ignorance over Knowledge

"William Johnson and his wife, Jill Johnson, of Ontonagon, were asked to be foster parents to their grandchild, according to a lawsuit filed in federal court," [Michigan Live reported](#) in a Sunday update to a story that broke in mid-July. "But William Johnson was surprised when caseworkers asked for the serial numbers for all of his guns and allegedly told him, 'if you want to care for your grandson you will have to give up some of your constitutional rights.'

"[T]he Johnsons, along with the Second Amendment Foundation and Brian and Naomi Mason, argued ... that the policy improperly restricts the constitutional rights of foster parents," the story elaborates. "The state rule 'as-applied functionally restricts foster and adoptive parents, and would-be foster and adoptive parents, the rights and privileges of possessing and bearing readily-available firearms for self-defense and defense of family,' the lawsuit alleges."

It should be no surprise that such infringements are not limited adoption situations. Divorce can bring its own complications into the mix. "Parents who own guns can have custody of children, but the way the guns are used, stored, and kept could become controversial issues when it comes time to for family courts to decide on custody or visitation issues," [LegalMatch.com notes](#).

And so-called "[safe storage laws](#)" mean no "special circumstances" like adoption or divorce are needed for the state to remove children from the home if their orders

aren't obeyed. And it's all done under the deceptive "for the children" slogan, even when disabling or putting guns out of reach demonstrably make things more dangerous for all.

That was definitively demonstrated in a now-mostly forgotten incident I referred to as an afterword on an old post on why giving the advantage of even [two seconds](#) to violent attackers is self-defeating:

"Dennis Henigan of the Center to Prevent Handgun Violence drops the ball in front of a roomful of reporters, while trying to prove the efficacy of Saf-T-Lok, a purportedly easy-to-use combination lock in the gun's grip.

Henigan fumbles and fails to unlock the gun in a well-lit room with no intruder at the door... Finally disengaging the safety, he apologizes, 'Most people aren't as klutzy as I am.'"



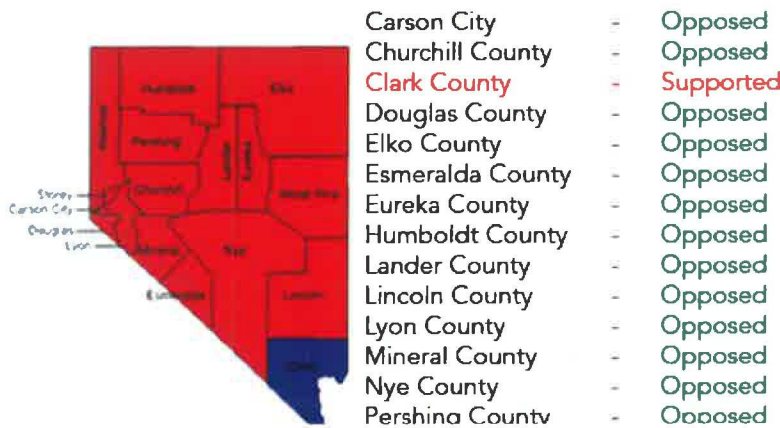

Not only did Nevadans in all but one county (and most sheriffs) not support the Bloomberg measure, it was written so poorly the FBI said there was no way they could legally cooperate. So why is a police union representing members who took oaths to support the Constitution demanding enforcement?

"As the leader of the Nevada Association of Public Safety Officers - the largest statewide affiliation of law enforcement associations in Nevada, representing more than 1,500 law enforcement professionals - I am calling on Attorney General Laxalt to do his job," NPSO executive director Rick McCann [tells Reno Gazette-Journal readers](#). "As the state's top cop, he can and should work with both Nevada's Department of Public Safety and federal officials at the National Instant Criminal Background Checks System (NICS) to find a path forward, ensuring that law enforcement in our state are protected when they risk their lives to protect ours."

He's referring to the Michael Bloomberg-led Question One "background check" initiative that passed in Nevada in November, albeit by less than one percent of the vote, failing in all counties but populated Clark (so much for the lie that voters overwhelmingly supported it). And [Laxalt really had no choice](#), as the FBI has no authority to allow unauthorized intermediaries to run background checks, a determination made because state law was written in conflict with federal.

Unacknowledged by McCann is that [a majority of Nevada sheriffs opposed the initiative](#). And unaddressed is how the measure would protect lives, especially since even the National Institute of Justice admitted in its 2013 "[Summary of Select Firearm Violence Prevention Strategies](#)" that ""Effectiveness depends on the ability to reduce straw purchasing, requiring gun registration."

Seeing as how violent prohibited persons are immune from being required to register because the Supreme Court ruled that would [violate their Fifth Amendment-guaranteed right](#) against self-incrimination, it would seem the very people McCann uses to justify his concerns will just keep on violating the law regardless.

Besides, note he didn't say he wanted to ensure citizens are protected, and that plays on the same rationale he used when stumping for Question One's passage:

"Our job is basically to protect officers around the state," [McCann said at the time](#).

Some might argue their members' primary job is to keep the oath they took to the Constitution, that is, to "the supreme Law of the Land."

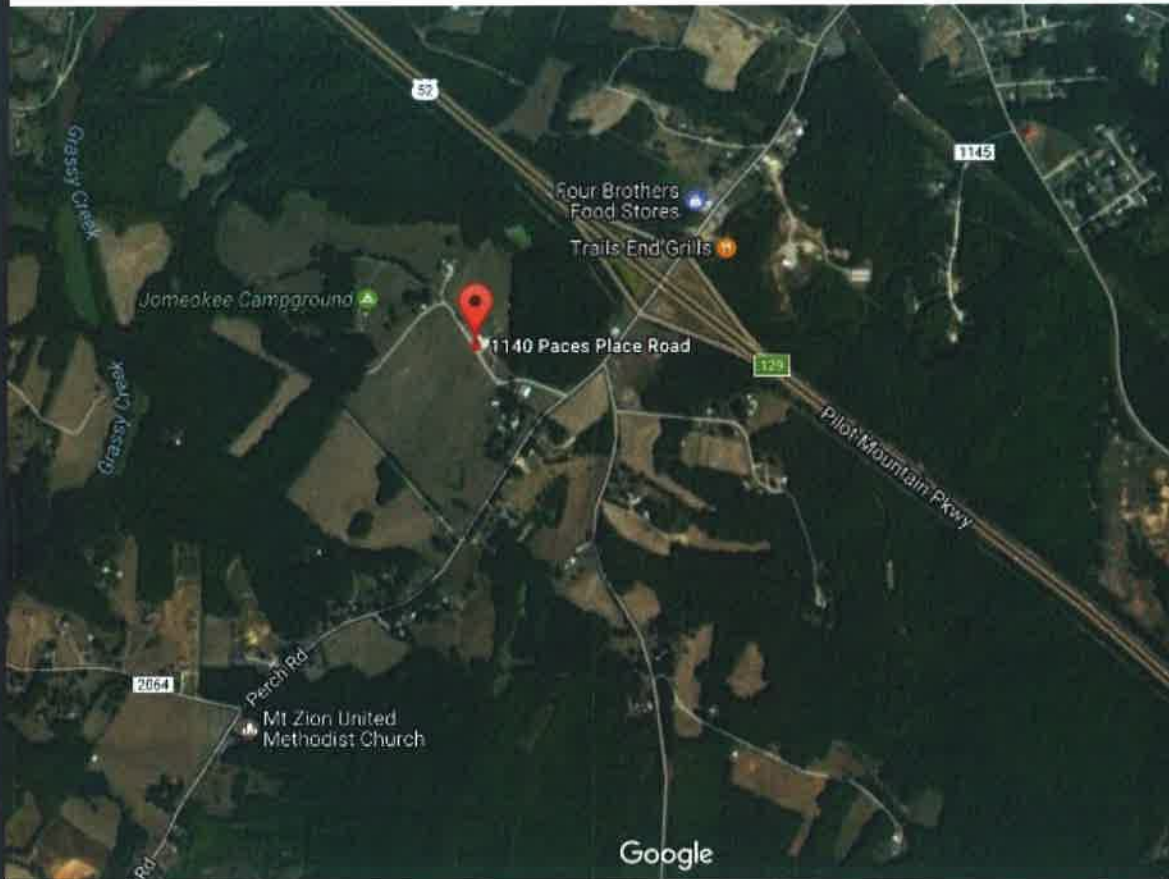

Right Questions Can Help the Uninformed Think Past Anti-Gun Disinformation

The men who assembled in 1775 were ordinary people caught up in extraordinary events. Who is certain he will forever escape having to make such a choice because times and people have changed for the better? (Henry Hudson Kitson's The Lexington Minuteman statue (1900))

It's time to revisit some basic questions I've asked before in columns of mine that have long since disappeared from the internet. It's time because of the contempt gun owners continually receive from the media and from "progressive" politicians and activists, it's time because the questions are still valid, and it's time because it looks like things are starting to heat up.

When did self-defense become morally wrong?

If someone violently attacks me or my family, is it wrong for me to resist? Do I not have a right to life?

Forget about me. How about your elderly mother?

If someone with intent to rob, degrade, beat, rape and butcher attacks her, would she be morally at fault for protecting herself?

How about it? Does this elderly woman have the right to repel a monster?

Yes or no?

I suspect, if put in those stark terms, the outcome of most polls would shift dramatically in favor of the right to individual defense. This, in turn, opens the door to discuss which means of defense is most effective at deterring an assailant, especially one who can brutally overpower his intended victim.

The message for which those of us in the pro-gun owner rights camp are vilified is no more complicated than this: Each of us has a right not to be hurt by someone else, and if someone tries to hurt us, we have a right to protect ourselves.

The corollary to this fundamental truth is equally simple: We cannot effectively protect ourselves without possessing the means of defense.

Let me ask another basic question. What is a right?

Is it something that is granted by a government authority? If so, how does that differ from a privilege? Can something that is granted be withheld? Can something that is licensed be revoked?

Are rights not unalienable? Do they not precede the establishment of government? Are they not, in fact, outside the authority of government? Does our Second Amendment say the right it articulates "may be infringed" or "shall not be infringed"?

"In Richmond, Attorney General Jeff Sessions says he will expand Project Exile nationwide," [the Richmond Times-Dispatch reports](#). "Project Exile is a widely copied program credited with cutting Richmond's violent crime 20 years ago by shipping firearm violators to far-off federal prisons. When [FBI Director] Comey was appointed director of the FBI, Exile was frequently cited as one of his accomplishments."

Except it wasn't really as big of an accomplishment as he (and the National Rifle Association) cracked it up to be, but it does go hand-in-fisted-glove with NRA Executive VP [Wayne LaPierre's longstanding position](#):

"Let's agree on this: Every American city, let's put Project Exile, every time a violent felon, drug dealer, gang member touches a gun, let's prosecute."

[At the time](#) then-NRA president Charlton Heston was telling "criminals" to "Make my day" as he joined with anti-gun then-Philadelphia mayor Ed Rendell to implement the program there, even though the numbers hardly substantiated the grandiose promises:

"In the final hours of 2004, Richmond topped its 2003 murder rate by one, securing its distinction as one of the nation's most dangerous cities.

"The city's final homicide of the year - called in to police around 8 p.m. New Year's Eve was number 95, surpassing the previous year's 94. In 2002, there were 83 and in 2001, 69.

"Murders in the United States dropped by nearly 6 percent in the first half of 2004 after rising for four straight years, the FBI reported. Numbers from the second half of 2004 have not been compiled.

"Richmond had the country's fourth highest murder rate in 2003 and was ranked the nation's ninth most dangerous city overall in 2004 _ beating out Miami and Compton, Calif. Richmond is the sixth most dangerous when compared to other cities with populations of 100,000 to 499,999."

And while there was "a steep decline" [reported in 2011](#), a [2016 report](#) noted "Richmond ranks high among 'murder capitals' in the U.S." and [doubts about Exile](#) were raised by the surge. Care to see [how they're doing today?](#)

Besides which, since when is "effectiveness" a measure of Constitutionality? Where is the authority to do this? That's a question a group of us have been asking for years, and for which we have never received acknowledgement from Exile proponents, let alone a responsive answer. Perhaps it's time to resurrect and heed the objections and warnings of the [Project Exile Condemnation Coalition](#).

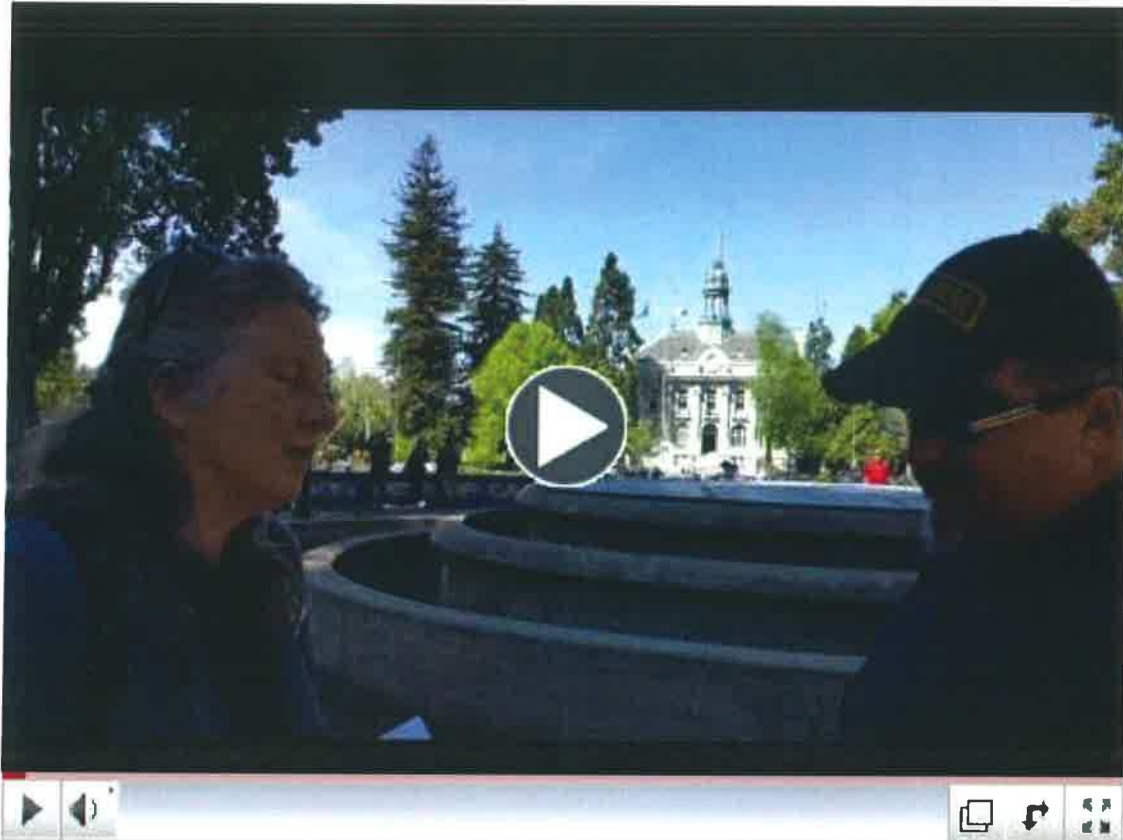

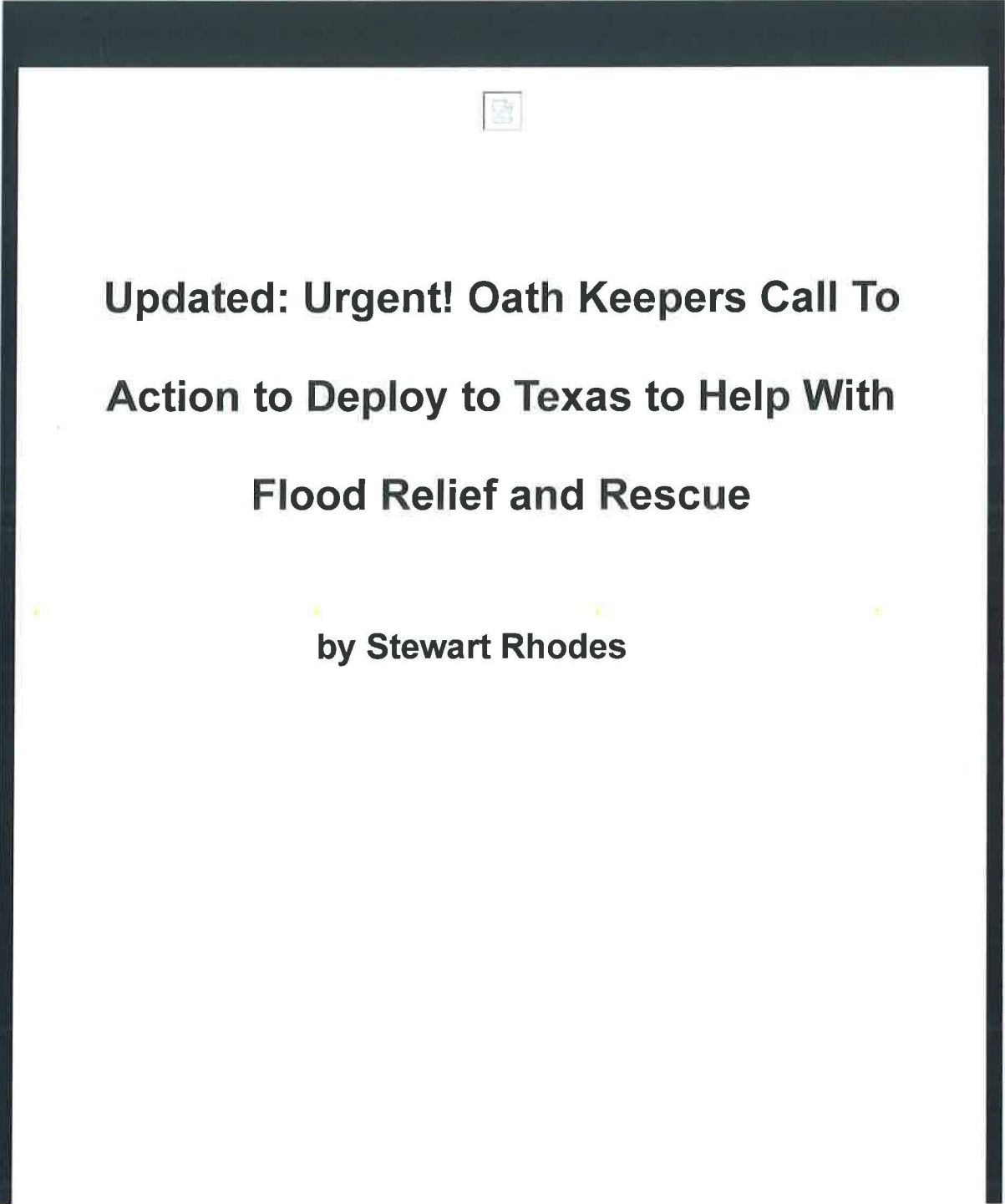

Our preliminary rally point is Livingston, TX, which is about 10 miles North of the first affected areas closer to Houston. At this time, Livingston is still dry.

There will be someone there 24/7 to check you in and direct you to where you need to go. Alex Oaks, the Oath Keepers Southern region assistant coordinator, is on scene, acting as our operation/logistics officer for this operation. Please call him when you are on your way, and he can give you the latest info on road closures.

DO NOT try to come in from due West or Due East, or South of Houston. For example, I 190 coming in from the East is flooded. Come in from the North, even if that means looping wide North. Come in from the North of Buffalo, TX or North of Lufkin, TX.

From Lufkin, TX take route 59 South to Livingston, TX.

From Buffalo, TX take I 45 South to Huntsville, and then take I 190 East, to Livingston. At this time, those routes are clear, but again, call Alex Oaks as you get into Texas and he will give you the latest updates on road closures.

Whatever your level of training or skill set, if you are willing to help we will find something for you to do.

For larger shipments of relief supplies or an up to date list of things needed contact Billy Simmons, Southeast Regional Leadership Coordinator, Board of Directors at [REDACTED]

However, we are in special need of:

1. People with boats! Even if you are not "search and rescue" trained, if you have a shallow water boat, come on down and we will pair you up with trained personnel. "Authorities" have put the word out that they don't want to see boats that draw more than a foot of water (sit lower than a foot deep in the water). And they don't want to see boats shorter than six feet long. But they are letting people use Jet Skis. Most of the Cajun Navy are using flat boats and pontoons.
2. Those with search and rescue training and experience, and/or folks who have already dealt with floods (been there, done that!) and can now help others. If you don't have a boat, but have the experience, come on down and we will pair you up with people with boats.
3. Medical personnel. From first aid to EMT, military or civilian medics, paramedics, nurses, doctors, etc. if you have any medical training you are sorely needed.
4. Security personnel or those with security related training (i.e. military or police, or other related training and experience). Unfortunately we have seen attempts to "boat jack" Cajun Navy volunteers committed by looters, who tried to take their boats by force, and also looters firing on Cajun Navy volunteers (the looters

want to scare us away so they can loot homes unmolested). Come armed, but see below for details on do's and don'ts. We are looking ONLY for calm, collected, cool headed professionals, as we used in Ferguson and on our other security operations. Must be well trained and competent. Expect extra vetting.

5. Communications: Any HAM operators, or otherwise trained in communications. We need the skills and the radios. Bring both and plenty of batteries.
6. Engineering and mechanics. If you can fix things and keep things running, we need you.

Please bring your personal provisions for:

- Sleeping (sleeping bag, pad, pillow, blankets, etc).
- Clothing, especially shoes and socks, keep your feet dry
- Gas mask, if you have one
- Rubber boots, or hip waders if you have them
- Toiletries, in zip lock bags
- Portable food
- Cash
- Personal protection in compliance with all laws
- Waterproofing for your phones
- First aid kit

We are directly assisting refugee shelters in and near Crosby, TX, but we DO NOT advise you to go there first, as Crosby may need to be evacuated.

The Texans showed up and helped when Louisiana was under water last year, just as they helped tremendously back during Katrina, opening their communities to thousands of refugees, and now it is time to help them in their hour of need.

We already have Oath Keepers on the ground helping out, right along with the heroes of the "Cajun Navy" who have come in from Louisiana to lend a hand at Texas Governor Abbot's urgent request. And we have more men on the way from Louisiana, Mississippi, Florida, and from within Texas itself.

By the grace of God we had a recent new member in Oath Keepers step up in a big way and donate 12,000 freeze dried meals, which we will be delivering in person, by private truck, tomorrow to a relief shelter in the Houston area. Texas Oath Keepers member Chance Gibson, owner of American Survival Wholesale, has donated 12,000 freeze dried meals, paid for with the generous donations from the supporters and clients of another awesome patriot, Ross Powell, owner of Survival 401k [REDACTED]

Chance provided the food at his cost, and Ross reached out to his contacts and within 24 hours they donated to Chance's page and had the food paid for. They did it so fast we didn't even have time to post up the donate link on our site, when it was all handled and Chance took the donate page down. Chance is now delivering the food

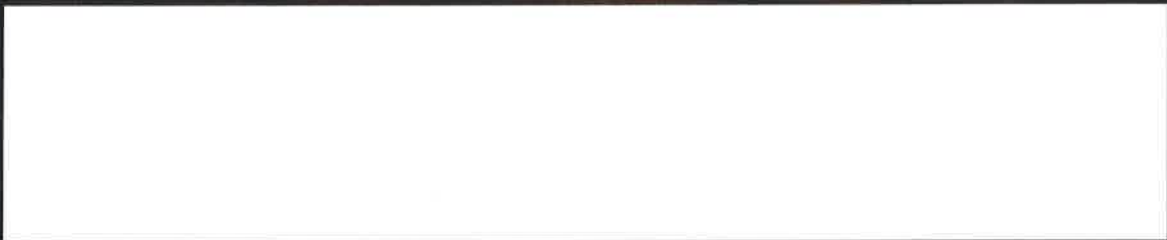

1. People with boats! Even if you are not "search and rescue" trained, if you have a shallow water boat, come on down and we will pair you up with trained personnel. "Authorities" have put the word out that they don't want to see boats that draw more than a foot of water (sit lower than a foot deep in the water). And they don't want to see boats shorter than six feet long. But they are letting people use Jet Skis. Most of the Cajun Navy are using flat boats and pontoons.
2. Those with search and rescue training and experience, and/or folks who have already dealt with floods (been there, done that!) and can now help others. If you don't have a boat, but have the experience, come on down and we will pair you up with people with boats.
3. Medical personnel. From first aid to EMT, military or civilian medics, paramedics, nurses, doctors, etc. if you have any medical training you are sorely needed.
4. Security personnel or those with security related training (i.e. military or police, or other related training and experience). Unfortunately we have seen attempts to "boat jack" Cajun Navy volunteers committed by looters, who tried to take their boats by force, and also looters firing on Cajun Navy volunteers (the looters want to scare us away so they can loot homes unmolested). Come armed, but see below for details on do's and don'ts. We are looking ONLY for calm, collected, cool headed professionals, as we used in Ferguson and on our other security operations. Must be well trained and competent. Expect extra vetting.
5. Communications: Any HAM operators, or otherwise trained in communications. We need the skills and the radios. Bring both and plenty of batteries.

6. Engineering and mechanics. If you can fix things and keep things running, we need you.

Oath Keepers

The Oath Keepers are a loosely organized group of right-wing anti-government extremists within the larger militia movement. While they allow anyone to join, the Oath Keepers explicitly focus on recruiting current and former military, law enforcement, and first responder personnel. The group was founded in 2009 by their current leader, Stewart Rhodes. The Oath Keepers gained notoriety for its armed participation in disputes between ranchers or miners and federal agencies in 2014 and 2015. They are also known for having provided vigilante-style "security" for local communities and businesses during Black Lives Matter protests in 2020. Members of the group have been arrested for a wide range of criminal activities, including various firearms violations, conspiracy to impede federal workers, possession of explosives and threatening public officials. Several Oath Keepers also played a prominent role in the January 6th storming of the Capitol building, and more than 20 have been arrested for their actions that day.
