IN CUSTODY: MCDONALD, OCTAYVIA M. // CHARGES: 720 ILCS 5.0/12-3-A-2 AND MCC 8-4-010(D) // COURT: BT 35-4 AT 1300 HRS ON 10JUL2020. IN SUMMARY, A/OS RESPONDED WITH BT 767 TO ASSIST AT A 10-1 POLICE EMERGENCY IN THE 001ST DISTRICT WHICH WAS RELATED IN PART TO MULTIPLE SCENES OF MASS UNREST INVOLVING AN INNUMERABLE NUMBER OF PARTICIPANTS. A/OS, WHILE PART OF A COORDINATED DISPERSAL EFFORT OVERSEEN BY BT 767 SGT. CORTESI #1146 AND BT 6791 LT. WOLF #431, MOVED N/B SHOULDER-TO-SHOULDER IN LINE WITH ASSISTING OFFICERS UNTIL EVENTUALLY MET BY MCDONALD, OCTAYVIA M. (ARRESTEE) AND OTHER "DIGBYS SECURITY" PERSONNEL AT OR ABOUT THE TOP OF A CTA STAIRWELL. 




