





A/o's responded to a call of reckless driver at the intersection of Chicago and Orleans involving a Uhaul Truck that had been driven up on the sidewalk, almost striking pedestrians. R/O's toured the area at which time the listed witnesses pointed out the listed U-Haul pickup truck (Arizona plate #AK05997), which was driving n/b on Orleans, as the Truck that had almost struck them. A/o's conducted a traffic stop and observed the offender (Montero) in the driver's seat. During traffic stop, A/o's observed a bottle of "Hennessy" on the passenger seat floorboard and detected a strong odor of alcohol emitting from within the truck. A/o's ordered the offender out of the truck and he was detained for further investigation. beat 1820 Sqt Kumiga #2426 arrived on scene. Offender was unable to walk on his own after exiting the vehicle and A/o's were able to sit him on a nearby curb. While investigation was being performed, A/o's spoke with (witness) who observed the offender drive through a solid red traffic light at the intersection of Chicago/Orleans and began driving erratically on the sidewalk. A/o's also spoke with 2 additional female witnesses ( and ) who related that the offender drove in their direction on the sidewalk but were unable to strike them due to a large light pole separating them. Female witnesses were able to record the incident on their personal phone and would supply it in court as needed. 




