THIS IS A BWC EVENT #18904 IN SUMMARY: WHILE RESPONDING TO A CALL OF A BURGLAR ALARM AT 841 W. 115TH ST A/O'S NOTICED SEVERAL CAR PARKED IN FRONT OF THE STORE WITH SEVERAL PEOPLE RUNNING IN AND OUT OF THE LOCATION AND SEVERAL CARS PARKED IN THE PARKING LOT. AS A/O'S APPORACHED THE STORE THE VEHICLES BEGAN TO FLEE THE SCENE. A/O'S SPOTTED THE ABOVE VEHICLE ATTEMPTING TO FLEE THE LOCATION.
