

DURING THIS TIME R/O'S NOTICED A GROUP OF CARS GATHERED IN FRONT OF BIG PAWN, R/O'S AT THAT TIME ACTIVATED EMERGENCY EQUIPMENT PULLED IN FRONT OF THE STORE WHERE MULTIPLE SUBJECT FLED FROM THE STORES AND INTO VEHICLES. 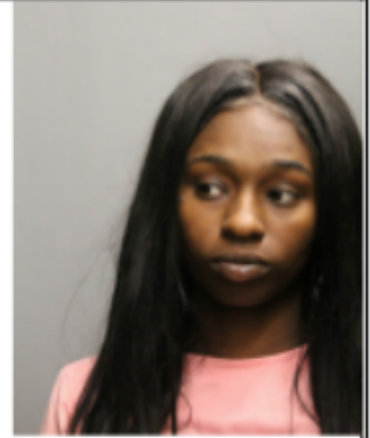
