Subject was then told he was being placed under arrest and to place his hands behind his back. Arrestee refused several verbal orders at which time an emergency take down was performed during which time Arrestee punched PO Wortham 8681 in the face causing redness and broken glasses. Offender kicked officer T. Howard 12913 in the right leg causing pain in an attempt to defeat the arrest. 
