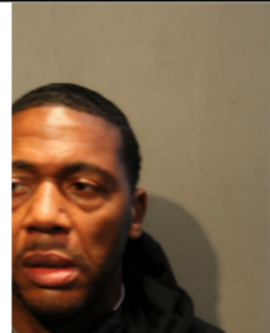

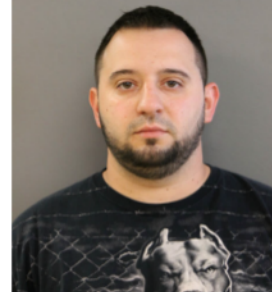

UPON OFFICERS APPROACH, R/O ADVISED OFFENDER TO PLACE HANDS OUTSIDE THE WINDOW AND TO SLOWLY EXIT THE VEHICLE WHILE KEEPING HIS HANDS UP. R/O OBSERVED AN UNCONCEALED HOLSTERED FIREARM ON OFFENDERS HIP AND RECOVERED WEAPON FOR OFFICER SAFETY. SUBJECT WAS THEN DETAINED UNTIL FURTHER INVESTIGATION.
