EVENT #14650 IN SUMMARY, THE AREA ONE 6714 GANG ENFORCEMENT TEAM WAS FLAGGED DOWN BY CONCERNED CITIZENS (WHO PREFERRED TO BE REMAIN ANONYMOUS FOR FEAR OF RETALIATION) WHO RELATED THAT THE SHOPPING CENTER AT ABOVE LOCATION WAS BEING LOOTED BY NUMEROUS INDIVIDUALS. R/OS THEN RESPONDED AND OBSERVED ABOVE A M/1 WEARING A BLK HOODY (NKA KELVIN MOON(OFFENDER)) RUNNING W/B TOWARDS A UNK MAROON SEDAN. OFFENDER WAS ALSO HOLDING SEVERAL BEAUTY SUPPLY ITEMS FROM A LOOTED BEAUTY SUPPLY STORE.
