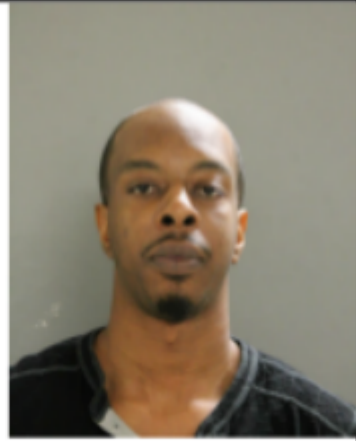

	<p>EVENT #15998: EVENT RECORDED ON BWC. A/O'S IN FULL UNIFORM IN AN UNMARKED CPD UNIT. IN SUMMARY, WHILE A/O'S WERE ON ROUTINE PATROL, A/O'S OBSERVED A GRAY CHEVY MALIBU BEARING ILLINOIS LICENSE PLATE OF [REDACTED] STOPPED AT THE INTERSECTION OF 84TH AND HOLLAND. A/O'S WERE BEHIND THE VEHICLE WHEN A/O CARNEY #16780 OBSERVED THE DRIVER OF THE VEHICLE, NOW KNOWN AS CARL BRANDON (CO-ARRESTEE), PUT HIS LEFT ARM OUT THE DRIVER SIDE WINDOW AND OBSERVED A GRAY FRAME FINISH FIREARM WITH A BLACK MAGAZINE ON THE WEAPON. VEHICLE THEN PROCEEDED TO EXIT THE WALMART LOT AND HEADED SOUTH ON HOLLAND WHEN A/O'S ACTIVATED THEIR EMERGENCY EQUIPMENT TO CONDUCT A TRAFFIC STOP. UPON APPROACH OF THE VEHICLE, A/O'S IMMEDIATELY REQUESTED BOTH DRIVER AND PASSENGER, NOW KNOWN AS KENDALL WILLIAMS (OFFENDER), OUT OF THE VEHICLE WERE DETAINED. SEARCH OF THE VEHICLE REVEALED A 9MM GRAY FRAME FINISH SMITH AND WESSON SD9 SEMI-AUTOMATIC FIREARM INSIDE THE GLOVE BOX WITH NO MAGAZINE ON THE PISTOL. PISTOL WAS NOT IN SLIDE LOCK. A LOADED MAGAZINE WITH AN UNKNOWN NUMBER OF LIVE ROUNDS IN IT WAS ALSO RECOVERED FROM THE GLOVE BOX. SUBJECT OF THIS ARREST REPORT RELATED TO A/O'S THAT IT WAS HIS GUN AND THAT HE HAS A FOID CARD FOR IT. KENDALL WILLIAMS WAS THEN MIRANDIZED AT 1702HRS ON SCENE TO WHICH HE RELATED NOT VERBATIM, THAT AT SOME POINT THE DRIVER (CO-ARRESTEE) HAD GOTTEN THE WEAPON OUT OF THE GLOVE BOX AND LATER THE DRIVER (CO-ARRESTEE) HANDED HIM THE WEAPON. AFTER THE CO-ARRESTEE HANDED HIM THE WEAPON, SUBJECT PLACED IT INSIDE THE GLOVE BOX. BOTH DRIVER AND PASSENGER WERE TRANSPORTED THE 6TH DISTRICT FOR FURTHER PROCESSING. AT THE 6TH DISTRICT, DRIVER WAS MIRANDIZED AT 1722HRS TO WHICH HE RELATED, NOT VERBATIM, THAT THE PASSENGER (ARRESTEE) HANDED HIM THE WEAPON BECAUSE THERE WERE PEOPLE WITH GUNS IN THE AREA. DRIVER (CO-ARRESTEE) THEN GAVE THE WEAPON BACK TO THE PASSENGER, TO WHICH HE PLACED IT IN THE GLOVE BOX. OFFENDER DOES HAVE A FOID CARD BUT NO CCL. WEAPON INVENTORIED UNDER #14712759. 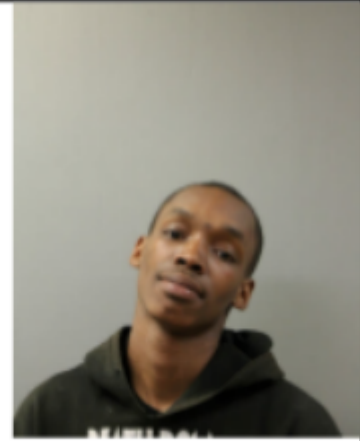
