

EVENT #15498. BWC RECORDED INCIDENT. ARREST MADE BY 011TH DISTRICT TACTICAL TEAM. A/O'S WERE IN FULL CHICAGO POLICE UNIFORM AND MARKED CHICAGO POLICE SUV. IN SUMMARY, A/O'S NOTICED CO OFFENDER COBBS, DION (CB #19964344) TO BE HOLDING HIS FRONT WAISTBAND AND BEGIN TO WALK AWAY FROM A/O HASAN AND A/O JOHNSON. A/O'S GAVE CHASE AND APPREHENDED CO OFFENDER AT ABOVE LOCATION. DURING A/O'S ATTEMPT TO PLACE COBBS, DION IN CUSTODY A/O'S WERE QUICKLY SURROUNDED BY A LARGE CROWD WHO ATTEMPTED TO HELP COBBS, DION ESCAPE. 

ARRESTING OFFICERS APPROACHED THE LARGE CROWD TO ADDRESS A PUBLIC SAFETY CONCERN (COVID-19).
