The burglary at walgreens event #04027 involved the U-Haul truck injuring a police officer. Beat 1845 provided a FLASH message describing 2 M/1's and 1 F/1 while in a foot pursuit fleeing S/B on Madison after crashing a U-HAUL truck at 727 W. Madison. The FLASH message contained the description of a M/1 wearing a grey hoodie, blk jeans, and white gym shoes. Sgt. Rigan star #1279 (Beat 1884) related via radio that the offender may be hiding under a vehicle near A/O's location of Monroe/Green. A/O canvased the area and discovered a M/1 hiding under a BLK BMW at 26 S. Halsted St. Arrestee was positively ID'd by Sgt Rigan as the offender that fled on foot from the passenger seat of the above Uhaul truck. Arrestee also identified as the offender that fled the original burglary scene and dove into the passenger window to make good his escape. Arrestee was taken into custody at 0514HRS by Beat 171.
