EVENT #10728 IN SUMMARY: A/OS WERE CALLED INTO ASSIST THE 001ST DISTRICT WHICH HAD A PROTEST AROUND THE AREA OF STATE AND HARRISON WHERE SEVERAL POLICE EMERGENCIES HAD OCCURED AND SEVERAL OFFICERS HAD BEEN INJURED BY UNRULY CROWDS. A/OS THEN HEARD SEVERAL LOUD REPORTS DIRECTLY SOUTHEAST OF THEIR LOCATION IN A PARKING LOT. AN UNKNOWN OFFICER POINTED IN THE DIRECTION OF THE SHOTS FIRED AND STATED THAT HE SAW SOMEONE RELOADING A FIREARM. A/OS THEN RAN TOWARDS THE DIRECTION OF THE SHOTS FIRED AND OBSERVED A MALE BLACK ENTER THE REAR PASSENGER SIDE OF THE ABOVE LISTED VEHICLE. A/O DEYOUNG AND MORRIS ILLUMINATED THE INSIDE OF THEIR VEHICLE WITH THEIR FLASHLIGHTS AND A/O MORRIS OBSERVED THE OFFENDER MANIPULATING AN OBJECT IN HIS WAIST AREA WHILE LEANING OVER. A/O MORRIS ORDERED THE OFFENDER, NKA KEVIN TUNSTALL, TO EXIT THE VEHICLE. AT THIS TIME A/O DEYOUNG OBSERVED THE OFFENDER SLIDE FROM THE REAR PASSENGER'S SIDE TO THE REAR DRIVER'S SIDE OF THE VEHICLE. A/O DEYOUNG OPENED THE REAR DRIVER'S SIDE DOOR AND OBSERVED A METALLIC OBJECT FALL TO THE GROUND AND MAKE A DISTINCT NOISE OF A FIREARM HITTING THE GROUND. A/O DEYOUNG WITH THE ASSISTANCE OF OTHER A/OS ASSISTED THE OFFENDER TO THE GROUND AND DETAINED THE SUBJECT. A/O LANE RELATED TO A/O DEYOUNG THAT HE OBSERVED A FIREARM FALL TO THE GROUND WHEN A/O DEYOUNG OPENED THE REAR PASSENGER DOOR. A/O LANE THEN RECOVERED THE FIREARM (BLACK SMITH AND WESSON, .40 CAL) AND MADE IT SAFE. A/O DEYOUNG THEN ASKED THE OFFENDER IF HE HAD A F.O.I.D. CARD OR CONCEAL CARRY LICENSE AND THE OFFENDER RELATED THAT HE DID NOT HAVE EITHER OF THOSE. THE OFFENDER THEN MADE AN EXCITED UTTERANCE STATING, NOT VERBATIM, THAT HE PICKED UP THE FIREARM AFTER HE HEARD THE SHOTS FIRED AND THEN RAN INTO THE VEHICLE THAT A/OS OBSERVED HIM IN. THE OFFENDER WAS TRANSPORTED TO THE AREA 3 AT 0148 HOURS BY BEAT 1215. CUSTODIAL SEARCH PERFORMED BY A/O DEYOUNG. AREA 3 DETECTIVES WERE NOTIFIED AND ON SCENE. .40 CALIBER SHELL CASINGS WERE FOUND ON THE SCENE OF THE SHOTS FIRED. P.O. SARLO #13131 FROM CRIME LAB WAS NOTIFIED AT 0243 HOURS.
