THE SAID DISPERSAL ORDER WAS DUE TO CIRCUMSTANCES WHERE THREE OR MORE PERSONS WERE COMMITTING ACTS OF DISORDERLY CONDUCT IN THE IMMEDIATE VICINITY, WHICH ACTS ARE LIKELY TO CAUSE SUBSTANTIAL HARM.
