EVENT#03756: IN SUMMARY, RO'S WERE DISPATCHED TO AREA 3 TO ASSIST WITH AN AGG. BATTERY TO A PROTECTED EMPLOYEE. RO'S WERE MET BY LIAPIS, ROBERT (VICTIM/CITY OF CHICAGO DETENTION AIDE) WHO STATED HE WAS PROCESSING OFFENDER EDWIN MARITNEZ.
