EVENT #2015318745, NOT A BWC RECORDED INCIDENT. IN SUMMARY, R/O'S WERE ASSIGNED DOWNTOWN FOR RIOT/PROTEST CONTROL. WHILE EN-ROUTE TO A 10-1 CALL AT THE INTERSECTION OF STATE AND KINSEY, R/O'S PATROL CAR WAS COMPLETELY SURROUNDED BY VIOLENT PROTESTORS. ONE WHITE MALE, OFFENDER#1 - UNKNOWN, WEARING A BLACK BASEBALL HAT, BLACK T-SHIRT, GRAY ATHLETIC SHORTS, BLACK SHOES AND HIGH BLACK SOCKS, JUMPED ON TOP OF THE PATROL CAR HOOD AND STARTED BANGING ON THE WINDSHIELD WITH A CLOSED FIST. R/O ACCELERATED THE VEHICLE A SHORT DISTANCE (APPROXIMATELY TWO FEET) THEN HIT THE BRAKES. THE OFFENDER THEN FELL OFF THE HOOD. THE OFFENDER THEN WENT TO THE DRIVER'S SIDE OF THE VEHICLE, STRUCK THE WINDSHIELD AGAIN, AND ATTEMPTED TO JUMP BACK ONTO THE VEHICLE, TO WHICH HE WAS UNSUCCESSFUL. AS THE OFFENDER MADE HIS WAY TO THE DRIVER'S SIDE OF THE VEHICLE, HE OPENED UP A PATH IN FRONT OF THE PATROL CAR, ALLOWING R/O'S TO CONTINUE NORTHBOUND TO THE 10-1 CALL.
