OFFICERS JOHNSON AND ALEQUIN WERE THEN ABLE TO APPREHEND COBBS ALONG THE FRONT SECURITY GATE AT 3331 W. MAYPOLE. AT THIS TIME, OFFICER ZEMAN WHO WAS STILL ON THE OTHER SIDE OF THE SECURITY GATE WAS ABLE TO GRAB HOLD OF COBBS' SHIRT AND HOLD ON TO HIM AS HE WAS STILL ATTEMPTING TO RUN TO DEFEAT THE ARREST. WHILE THIS WAS OCCURRING APPROXIMATELY 10 SUBJECTS BEGAN TO SURROUND THE OFFICERS. ONE OF THE INDIVIDUALS, D'ANDRE OTIS APPROACHED OFFICER JOHNSON AS HE WAS ATTEMPTING TO HANDCUFF COBBS.
