EVENT #21987. NOT A BWC INCIDENT. IN SUMMARY, WHILE ON PATROL R/O'S WERE WAIVED DOWN BY A CITIZEN WHO RELATED THAT MULTIPLE INDIVIDUALS WERE ATTEMPTING TO BREAK OPEN THE ATM AT A RESTAURANT AND LOOTING THE STORE AT 2145 S PULASKI. UPON ARRIVAL R/O'S OBSERVED NUMEROUS INDIVIDUALS, INCLUDING NKA HECTOR DELGADO(OFFENDER) AND JOHN DOE(OFFENDER) UPON THE PREMISES DURING NON-BUSINESS HOURS. ALL OFFENDERS BEGAN TO FLEE AS OFFICERS WERE ARRIVING. BOTH OFFENDERS PLACED IN CUSTODY AFTER BREIF PURSUITS. HECTOR DELGADO(OFFENDER) WAS TRANSPORTED TO THE 10TH DISTRICT AND RELEASED AFTER RECEIVING AN ORDINANCE COMPLAINT #L1-459-501 DUE TO THE COVID-19 PANDEMIC. WHILE JOHN DOE(OFFENDER) WAS BEING TRANSPORTED TO THE 10TH DISTRICT HE BEGAN BANGING HIS HEAD IN THE BACK OF THE SQUAD CAR AND RELATED, BUT NOT VERBATIM "IM GOING TO KILL MYSELF. PLEASE KILL ME." ALSO WHILE TRANSPORTING JOHN DOE(OFFENDER) TO THE 10TH DISTRICT THE CPD PATROL CAR BEGAN TO HAVE A MECHANICAL FAILURE AND WAS NO LONGER OPERABLE. ONCE THE VEHICLE BECAME INOPERABLE JOHN DOE(OFFENDER) BEGAN KICKING THE PATROL CAR DOOR WHICH CAUSED DAMAGE TO THE REAR DRIVER SIDE DOOR.
