Narrative

Investigators were assigned to process a scene of a Police Involved Shooting with a unnamed subject being shot and transported to Illinois Masonic Hospital by Chicago Fire Department Ambulance prior to our arrival and Investigators learned nka (Anthony Alvarez [REDACTED] 1999) had passed. Investigators arrived on scene and saw News Affair Tom Ahern taking pictures of the firearm with a cell-phone camera and left. Investigators met with Det. J. McCabe # 20547 on scene and walked us through the scene starting at 5237 W. Addison Ave. and ending at 5202 W. Eddy St. Investigators videotaped the scene and surrounding area of 5237 W. Addison Ave. and 5202 W. Eddy St. IRT Sgt. T. Flaherty # 1732 was searching also at 5200-5202 W. Eddy St. with IRT J. McCabe searching on his knees in the front grass of 5202 W. Eddy St. prior to Investigators searching. Investigators then searched the area of 5200-5202 W. Eddy St. and marked the firearms evidence with numbered CPD markers next to the CPD logo yellow markers and then photographed and collected the evidence in the presence of COPA Harris and IRT Det. Berg # 20139. Investigators then took electronic measurements of the scene for a plat. Investigators then collected the above evidence from the scene at 5202 W. Eddy St. and raked the front grass looking for any additional firearms evidence to no avail. Investigators learned of the subjects name by a paper copy of a Illinois Id in his pants pocket at the scene. Investigators then relocated to Area 5 Detective Division to photograph and recover officers P.O. Solano # 12874 (06:42hrs) and P.O.
