## 1 FEBRUARY UPDATE

As discussed last night, SOMEX please continue your search this morning. As you know the cab video was a dead end but we know the two targets walk NB on Marshfield to at least the 3700 block. Please use EVERY resource necessary to locate the targets. Manpower NP, just let me know what you need.

We tracked down a Sheraton security guard who is an eye witness immediately after the assault. For those of you that saw the Riverwalk POD video, he is the guy with the flashlight. Statement attached for your review. Keep in mind when reading this that he is a near minimum wage hotel security guard on midnights who by happenstance walked past two guys running in the opposite direction in a dark relatively unlit area at 0200 hours in sub zero weather. No offense to security guards everywhere. Respect. My first part time job as a young PO was as a security guard at a hotel on midnights. It sucked. I lasted there about a month. I did get a date from the hot front desk manager though so it wasn't a total loss.

Random thoughts:

Why did our targets get out of cab at Marshfield and Addison then walk at least one block NB? It's cold in the middle of the night. Did they anticipate tracking? Where could they be going? They've got to live right there right?

In my opinion, determine which PODS may be useful, order those PODS and then use the exported DATA to conduct the investigation.

As I am doing it on the live server, I see lots of compression related issues, for example, much of the screen is greyed out when you begin watching footage.. this is due to Temporal Compression Schemes.

To help with that, begin you viewing about 15-30 seconds BEFORE what you want to watch.. this lets the I-frame refresh the image.

You won't have the issue with the exported data.

4. Continue POD review to track path.
5. Verify and I mean verify that the victim got off a plane at O'Hare. Big Issue if this was a lie. CALL me as soon as this is completed.
6. Subpoena for victim and manager phone records. Bob Boike from the Superintendent's office has been negotiating with the victim's lawyer for cooperation but it is unlikely we will get it. Victim has now declined several times but yesterday afternoon became desperate because he wanted to get us to tell the media we validated that he and his manager were on the phone at the time of the assault and that the manager overheard part of the assault.
7. Take cab SD card somewhere, RCFL? To confirm we can't recover overwritten video showing our targets. Not a priority because this is unlikely, unless someone knows better.
8. Review data archives of the NSA satellites geospatially positioned over the northside of Chicago and track our targets. Authorization [REDACTED] granted. Don't forget to zoom in on their faces then submit to facial recognition.

Update regarding JC-133190: Detectives Corfield #20613 and Santos #21429 interview of [REDACTED]

[REDACTED] is a lost prevention officer employed by the Sheraton Grand Hotel, located at 301 E. North Water St. [REDACTED] was on-duty on 29 Jan 19 at approximately 0200 hours.

On 31 Jan 19, in furtherance of this investigation, the above cited detectives relocated to the Sheraton Hotel and interviewed [REDACTED]

The following is a synopsis of that interview. For a more complete account of the interview please refer to the relevant GPR.

[REDACTED] related that he was working as a lost prevention officer on 29 Jan 19 at approximately 0200 hours.

[REDACTED] related that he was conducting his rounds and entered the Chicago Burger restaurant which is located inside of the Sheraton Hotel and was closed at that time.

[REDACTED] related he exited the door to the River Walk when he heard footsteps. [REDACTED] described the footsteps as "running" footsteps.

[REDACTED] encountered a male subject who was running. [REDACTED] shined his flashlight and asked the subject what he was doing and the subject replied in essence that it was cold out. The subject then continued to run westbound down the River Walk. [REDACTED] related that he did not see any object in the subject's hands.

[REDACTED] described the above listed subject as follows: Male, approximately 6'0" tall, average build, all dark clothing, wearing a facemask and a hoody or hat. [REDACTED] did not specify if there was anything on the hat. [REDACTED] related that the subject appeared to be a white male. It should be noted that only a small portion of the subject's face was visible according to [REDACTED]

[REDACTED] related that moments later (within seconds) he encountered a second subject who was running in the same direction as the first subject. [REDACTED] related that this subject pointed to the first guy and continued to run westbound and was laughing.

[REDACTED] described the second subject as a Male, but more stocky than the first subject. [REDACTED] related he could not see the second subject's race because it was covered by his arm while pointing.

[REDACTED] related that after the second subject ran away he looked towards the stairs which lead to upper Water St. [REDACTED] related that he observed a male individual near the bottom of the stairs picking something up off of the ground.

-Detectives showed [REDACTED] a still photograph captured from the POD camera which depicted two unknown subjects. [REDACTED] identified those two subjects as the same two subjects he encountered on 29 Jan 19 at approximately 0200 hours.

-Detectives indicated that [REDACTED] account appears to be corroborated by some of the video which was recovered.
