R/D was aware that on 14 Feb 2019, "Good Morning America" ("GMA") aired an interview between Jussie SMOLLETT and "GMA's" Robin ROBERTS.

On 05-06 March 2019, as a member of the Area Central SOMEX team, Reporting Detective (R/D) assisted with this investigation. R/D logged on to the Internet through Chicago Police Department computer to locate and review the video. The headline for this "GMA" video is "JUSSIE SMOLLETT SPEAKS OUT 'Empire' star breaks his silence in first interview."

In this interview SMOLLETT speaks with ROBERTS about the attack that occurred on 29 Jan 2019, in which he reported to the Chicago Police Department (CPD) under RD# JC133190. REFER TO VIDEO FOR FULL CONTENT. Below, is a summary of this interview.



Robin ROBERTS leads into the interview by saying that this interview was musician and actor Jussie SMOLLETT's first interview since that night in Chicago. In the interview, SMOLLETT tells her how he is doing now and his response to those who doubt his account.

R/D found an article on-line 06 Mar 19 which was written on 05 Mar 19 by Suzy Byrne, Editor, Yahoo Entertainment "Robin Roberts says her interview with Jussie Smollett was a 'no-win situation for me.'" This article noted the GMA co-host sat down with the Empire actor Feb 12 [2019] and that the interview started two-and-half hours late. The interview was aired two days later, on 14 Feb. This article was inventoried under# 14406164.

SMOLLETT starts the interview by saying he is pissed off – at the attackers, at the attacks and how people don't believe the truth or want to see the truth. He gives an account of what had happened to him, leading up to the attack. At approximately 1:36, in the interview, SMOLLETT tells what happened to him while he was on the phone with his manager. "I heard, as I was crossing the intersection, I heard 'Empire.' And I don't answer to Empire. (laughs). My name ain't 'Empire.' Uh, and I didn't answer. I kept walking and then I heard '[BLEEP] Empire [BLEEP].' So I turned around and I said, 'what the [BLEEP] did you just say to me?' And I see the, uh, attacker, uh masked, and he said 'this AGA country [BLEEP],' punches me right in the face. So I punched his ass back. And then, um, we started tussling.

you know it was very icy and we ended up tussling by the stairs. Uh, fighting, fighting, fighting. There was a second person involved, who was kicking me in my back and, uh, then it just stopped. And, they ran off. And I saw where they ran."

SMOLLETT related his phone had fallen out of his pocket and his manager Brandon was still on the phone and Brandon asked him what was going on. SMOLLETT tells him that he "was just jumped." He continues to tell ROBERTS, "I looked down and see that there's a rope around my neck. Which I hadn't..." ROBERTS interjects and asks "you hadn't noticed it before, you...?" SMOLLETT tells ROBERTS that the attack "it was so fast, you know what I am saying? It was so fast." ROBERTS asked how long this all took. SMOLLETT replied, "it felt like minutes, but was probably was like, 30 seconds, honestly. I can't tell you honestly. Um, I noticed the rope around my neck and I started screaming and I said, 'there's a [BLEEP]ing rope around my neck."

SMOLLETT tells ROBERTS he "gave a body description" of the attacker, and points to face as to what he saw. He said he couldn't tell the colors of the eyes. SMOLLETT says, "I can't tell you, and I did not see anything, except the second person I saw running away and the first person, yeah I saw, saw his stature. I gave the description as best as I could." He goes on to say it is Chicago in the winter and people can wear ski masks and nobody's going to question that.

At 3:42 ROBERTS stated to SMOLLETT that the police had gone through a lot of video and captured an image of two people of interest. She asks, "have you seen that image? And, do you believe they could possibly be the attackers?" SMOLLETT's response, "I do." ROBERTS asks, "what is it about their, their size, or what, why do you feel they could possibly be?" SMOLLETT says, "cause I was there." He said that when that was released, "I was like, ok, we're getting somewhere." He goes on to say at approximately 4:08, "I don't have any doubt in my mind that, that's them. Never did."

SMOLLETT explains about his hesitation to call the police - he says a level of pride and privacy. SMOLLETT was "glad Frank called the police. Glad we reported it." As he waited a half hour for the police to arrive, he was checking himself out. He saw the bruise and rope burn around his neck. Then he smelled bleach and saw spots on his sweatshirt. He said, "When the police came, um, I kept the clothes on. I kept the rope." ROBERTS asks, "so, you had the rope on the entire time?" He said that the rope "yeah, it wasn't like wrapped around, but yeah it was around." SMOLLETT wanted to show the police, to see what this was. SMOLLETT told police what happened, also asked them to turn off the body cameras. He did not want to make a big scene with the neighbors.

With the "second round" of Officers, SMOLLETT says he took them to where it happened and walked them through what exactly happened. SMOLLETT looked up and he saw there was a camera directly on the light post in the intersection. SMOLLETT says, "I'm like, there it is." ROBERTS mentions this as "potential break in the case that could eventually fall apart days later." SMOLLETT said the Detective told him the camera in the casing was facing north, so they [police] didn't have it [the attack on video]. SMOLLETT said, "that was disappointing."

ROBERTS brings up about vast majority of people supporting him, but then as time has gone on, "You know, it's 2 o'clock in the morning, you're going to Subway, sub-zero." SMOLLETT interrupts to talk about Subway open 24-

hours, and that's where people go when they are hungry at night and they don't have food. He mentions the camera facing north, how is that his issue?

SMOLLETT continues to talk to ROBERTS about the doubters of his attack. He says, "it feels like, if I had said, I'm a Muslim, or a Mexican, or someone black, I feel like the doubters would have supported me a lot much more, a lot more." He goes on, "It says a lot about the place we are in our country right now. The fact that we have these fear mongers. These people that are trying to separate us, and, it's just not ok. It's just not ok. And for all the people, the next time that you see someone report something, maybe well after the fact that it happened, and you say to them, 'why you waitin' til now?' Just remember that mine was reported right away, and look what has happened."

ROBERTS brings up SMOLLETT's phone and that he said it was an accurate account of the timeline, valuable information. She asks when were records made available for police. He says they didn't originally ask for records, they asked for his phone and that it would be given to a tech for 3-4 hours. SMOLLETT says, "I'm sorry, but I'm not going to do that." He states a number of reasons for not turning his phone over: private pictures and videos and numbers, etc. He goes on to say, "honestly, by then, inaccurate, false statements had already been put out there."

ROBERTS says that week he submitted phone records that were within an hour of the incident. But Chicago Police say the records were "limited and heavily redacted" adding they needed "additional information" to corroborate the investigative timeline. SMOLLETT's attorneys told "GMA" they are willing to cooperate.

SMOLLETT was troubled by inaccurate claims:

- He never said they were wearing "MAGA hats" - "I didn't need to add anything like that. They called me 'a [BLEEP]' they called me 'a [BLEEP]'. There is no which way you cut it. I don't need some MAGA hat as the cherry on top of some racist sundae"
- The attack was a "date gone bad" - he resents that narrative. He says he's, "Not gonna go out and get a tuna sandwich and a salad to meet somebody. That's ridiculous and it's offensive." He talks about dating sights - which he states he hasn't been on in years; he did that when he was single. He says "it's offensive and I absolutely resent that narrative because it's bull, it's bull. And, it's unfair, it's unfair to the investigation. It's unfair to, I hate this word, but it's unfair to the victim."

ROBERTS asks about injuries:

- X-rays were done. SMOLLETT claimed that it was reported he had fractured or cracked ribs. He stated that was not true. He was just in a lot of pain. He says, "my clavicle was messed up, my rib was, um, was bruised." He tells ROBERTS he walked into and out of the hospital.

ROBERTS asked him why he thinks he was targeted. SMOLLETT says, "I can just assume, I mean, I come really, really hard against 45 [President Donald TRUMP]. I come really, really hard against his administration and, I don't hold my tongue." GMA shows the clip of President TRUMP making a statement regarding SMOLLETT. When ROBERTS asked if SMOLLETT heard about it, SMOLLETT was unsure what to say to that, but appreciated that he [the President] did not brush over it [his attack].

ROBERTS asks, "And, there is no doubt in your mind, what motivated this attack?" He responds, "I can go only on their words. I mean, who says '[BLEEP] Empire [BLEEP]', this MAGA country [BLEEP]', ties a noose around your neck and pours bleach on you, and this is just a friendly fight? I will never be the man that this did not happen to. I am forever changed. And I don't subscribe to the idea that everything happens for a reason. But, I do subscribe to the idea that we have the right and responsibility to make something meaningful out of the things that happen to us, good and bad."

ROBERTS asks, "What do you feel people need to hear the most from this story?" He says, "I think that what people need to hear, is just the truth, is just the truth. Cause everybody has their own idea. Some are healing, some are hurting." SMOLLETT wants young people, young members LBGQT community and young black children to know how strong they are.

Two weeks after, ROBERTS says SMOLLETT is still processing his emotions. SMOLLETT tells ROBERTS, "I got threatened all the time on Twitter and Instagram and DMs and things like that." He realizes he's a public figure, he's very outspoken, but that is who he is and he gets the idea of pissing people off and he's going to rub people the wrong way.

They talk about the letter sent to Fox studios a week before the attack, with threatening language and laced with a powdery substance. ROBERTS asks SMOLLETT if he thinks there is a link between the letter and the attack, which he mentioned to the police right away, about the letter. SMOLLETT's response, "Um, just because on the letter it had a stick figure hanging from a tree, with a gun pointing towards it, with the words that said 'Smollett Jussie you will die black [bleep]'. There was no address but the return address said in big red, you know like caps, 'MAGA'. Did I make that up too?"

ROBERTS says SMOLLETT hopes to rewrite the narrative – that he fought back against his attackers and reported it after his creative director called 911.
 [They play portion 911 audio].

SMOLLETT wants the video to be found "so badly." For, probably, four reasons:

- 1 Find the people that did it
- 2 He wants them to stop being able to say "alleged" attack
- 3 He wants them to see that he fought back. He wants, a little gay boy, who might watch this, to see that he fought back – they ran off – he didn't

[Number 4 was not stated]

ROBERTS asks, "What do you say to a young gay man, a young gay person?" SMOLLETT relates he wants them to arm to fight, be a fighter. He is not advocating violence – at all. He says, "if you're going to die, fight until you do; because, if you don't fight, you have no chance. I have fought for love. I am an advocate, I respect too much the people, who I am now one of those people, who have been attacked in any way; you do such a disservice when you lie out things like this."

ROBERTS asks how he will heal if the attackers are never found. SMOLLETT begins to cry, "Um, I don't know. I just let us hope that they are. You know what I'm saying? Like, let's, let's not go there yet. Let's um, I was talking to my friend and I said, 'I just want them to find them.' And she said, 'sweetie they're not gonna find them.' That just made me so angry because, so I'm just going to be left here with this? You know what I'm saying? Like, I'm going to be here, with, with like, so they get to go free and go about with their life and possibly attack someone else, and I'm here, left, I'm left with the aftermath of this bull. That's not cool to me. That's not ok. So, I understand how difficult it would be to find them, but we got to. I still want to believe, with everything that has happened, that there is something called justice. Cause if I stop believing [unintel], then what's it all for?"

The interview ends with "thank you" being said by ROBERTS and SMOLLETT.

R/D sought assistance from PO GILBERT #15552 to capture and download this interview to disc, which was subsequently inventoried under# 14406164. Copies of the disc were produced for the investigation.

R/D was aware of statements Jussie SMOLLETT made at his concert, 02 Feb 2019, at the Troubadour in West Hollywood CA, four days after an attack he reported to Chicago Police under RD# JC133190.

R/D logged on to the Internet, through a Chicago Police Department computer, to locate/review video that captured these statements. R/D sought assistance from PO GILBERT #15552 to capture and download video to disc; subsequently inventoried under# 14406177. Copies of the disc were produced for the investigation.

PO GILBERT downloaded two videos from YouTube:

- Video clip 8:20 - Posted by WLN - What's Live Now – "Jussie Smollett, Live at The Troubadour"
Published on Feb 2, 2019, below left captured image
- Video clip 1:03:24 - Posted by WLN - What's Live Now – "Jussie Smollett, Full Troubadour performance"
Published on Feb 19, 2019, below right captured image



REFER TO VIDEOS FOR FULL CONTENT. Below is a summary of the statements made at the concert.

At the 8:20 clip: SMOLLETT is on stage and addressed the crowd with, what appears to be, a piece of paper in his hand. He says that there is a lot he hasn't been able to say and that there is stuff said that is "absolutely not true." SMOLLETT says, "I'm referring to my lawyer's sitting up there saying 'no Jussie, no, no shut the fuck up and sing.' Darrell, I'm sorry."

SMOLLETT says he wanted to make four points, but he diverts by first saying, "my little sister is literally like Olivia Pope – like, she's in the back."

He proceeded to share his four points:

- He was bruised but his ribs were not cracked, not broken
- He went to the Doctor immediately – [REDACTED] drove him – he was not hospitalized
- His doctors in LA and Chicago cleared him to perform but told him to take care
- And, above all, he said "I fought the fuck back"

SMOLLETT continues and says, "I'm the gay Tupac." He finishes his encore with a song while making more comments that R/D was unable to decipher at this time.

REFER TO VIDEO FOR FULL CONTENT. Below is a summary of the statements made at the concert.

The 1:03:24 video:

At the start of the video, the SMOLLETT family is on stage – the eldest brother, Joel SMOLLETT Jr, makes a statement about Jussie, what happened and the family is there to provide support. Joel SMOLLETT Jr, did not want Jussie to perform and to stay out of the public until he heals. However, the family debated and realized that Jussie performing was an important part of his healing. He said that Jussie's been a fighter since a baby and that he fought his attackers that night and continues to fight.

This video then captures the SMOLLETT family embracing Jussie as he comes onto the stage. SMOLLETT says he's not fully healed yet, but will stand strong. He says he had to be there, "couldn't let those motherfuckers win." He says he will only stand for love, regardless of what anyone else says. SMOLLETT then performs for the audience: singing, laughing and dancing.

At 28:20 he says, "I'm on a little show called 'Empire.'" He says his "Empire" family was there to support him. He also said he was honored to bring to life a character named Jamal LYON. The song he then performs is from the show and it has new meaning for him - called "Heavy."

At 50:50 he speaks about his next song and a "cycle of hurt" and mentions how he spoke about it when he released his statement the day before. He says, "that in times of trauma, or hurt, or grief, we still have the responsibility to lead with love. And if we don't, we just die inside." He talks about hateful rhetoric that gets thrown around – he's not naming names - in general - it has to stop. He says, "it stops with the people that believe in love." He admits being guilty of it too, saying that those who celebrate love, can actually get wrapped up into so much hate, that somehow it waters down love. He wants people to take love back.

Near the end of the video clip, 1:01:30, he speaks to the crowd saying he wasn't able to get through the last four days without his family and the love and support of the crowd. He says he doesn't take it lightly and hopes the people feel the love coming back. SMOLLETT is proud of himself and promised himself he wasn't going to cry.
