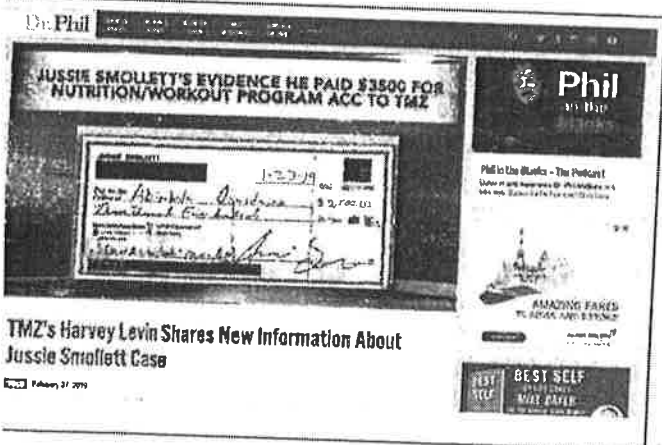

 On 28 February 2019, as a member of the Area Central SOMEX team, R/D assisted with this investigation.

R/D logged on to the Internet through Chicago Police Department computer to locate a video regarding the [redacted] case being discussed on "Dr. Phil." This video was found, posted on the "Dr. Phil" website "https://www.drphil.com" on 27 Feb 19 "TMZ's Harvey Levin Shares New Information About [redacted] Case." https://www.drphil.com/videos/tmzs-harvey-levin-shares-new-information-about [redacted]-case/

Dr. Phil spoke with Harvey Levin, the Executive Producer & Host "TMZ LIVE," via satellite. R/D reviewed said video and captured six images regarding the interview; included in Inventory# 14406155, along with two pages from "Dr. Phil" about the episode "TMZ's Harvey Levin Shares New Information About [redacted] Case."



[redacted] stated that they [TMZ] obtained the check and various text messages between [redacted] and one of the brothers.

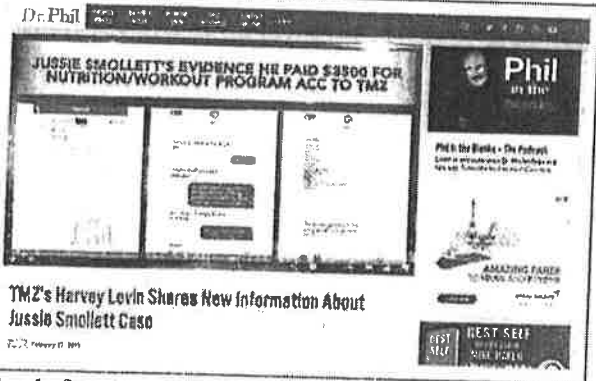

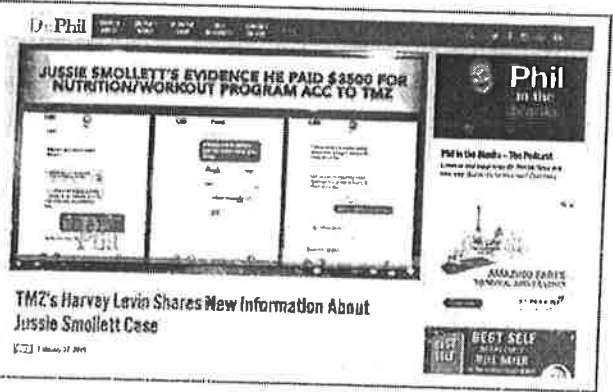

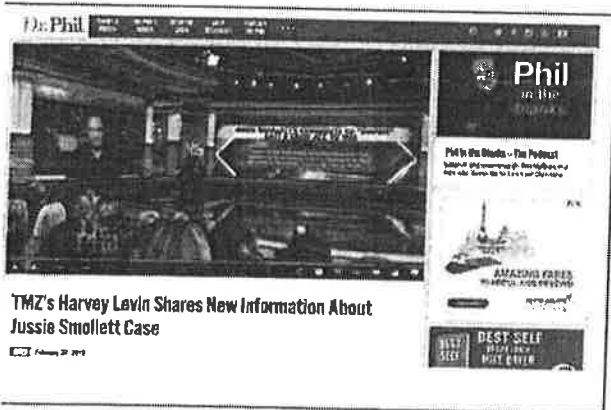

video shoot?" The text conversation continues on Fri, Jan 25, 9:17 AM with a Google Doc link [not viewable], which [redacted] describes as the meal plan, the breakdown of macronutrients and projected fat loss. [redacted] responds with "Cool i can't pull up on phone so gotta check on my computer. When do you leave town?" [redacted] replies, "I leave Tuesday night."

The middle screen capture posted next is not a conversation between [redacted] and [redacted] but rather a captured conversation, between [inferred to be] [redacted] and [redacted]. On Sun, Jan 27, 11:19 AM, [redacted] [possibly manager] [redacted] says "Videos are in yellow. Let me know what you think." There is a capture of a calendar R/D [redacted] s unable to read.

Lastly, the right screen capture posted, is again, conversation between [redacted] and [inferred by conversation made between Dr. Phil and [redacted] [redacted] dated Mon, Jan 28, 10:43 AM. [redacted] message is sent twice "I know you're traveling today, make sure you get at least 45 mins of cardio." On Mon, Jan 28, 2:35 PM [redacted] says, "Gotcha. Did it this morning." [redacted] reply is then featured twice Mon, Jan 28, 1:43 PM and at Mon, Jan 28, 3:26 PM saying, "Easy. Good work."

The last two images captured from the "Dr. Phil" segment's header reads, "[redacted] COMMENTS TO 'EMPIRE' CAST & CREW ACC TO TMZ." Followed with his statement, "I'm sorry I've put you all through this and not answered any calls. I wanted to say I'm sorry and, you know me, I would never do this to any of you, you are my family. I swear to God, I did not do this."



[redacted] sought assistance from PO GILBERT #15552 to download the "Dr. Phil" segment and transfer it to disc. R/D [redacted] lentoried disc under# 14406155. Copies of the disc were produced for the investigation.

R/D logged on to the Internet through a non-attributable computer, utilizing department approved covert account [REDACTED], with the Internet Protocol (IP) address of [REDACTED] in an attempt identify social media accounts or possible evidence on social media regarding the case.

R/D was made aware that a person of interest in above case ordered an Uber ride prior to the attack. Investigators served a subpoena to Uber. Uber's response revealed that the phone number used to order the ride was [REDACTED]. R/D logged into Facebook (FB) and said number is linked to the account of [REDACTED].



[REDACTED] responded to a post by FB account [REDACTED], FB ID# [REDACTED], in which they were in Nigeria.

R/D also located the FB account for "Team Abel" @TeamAbel3 with the FB ID# [redacted]

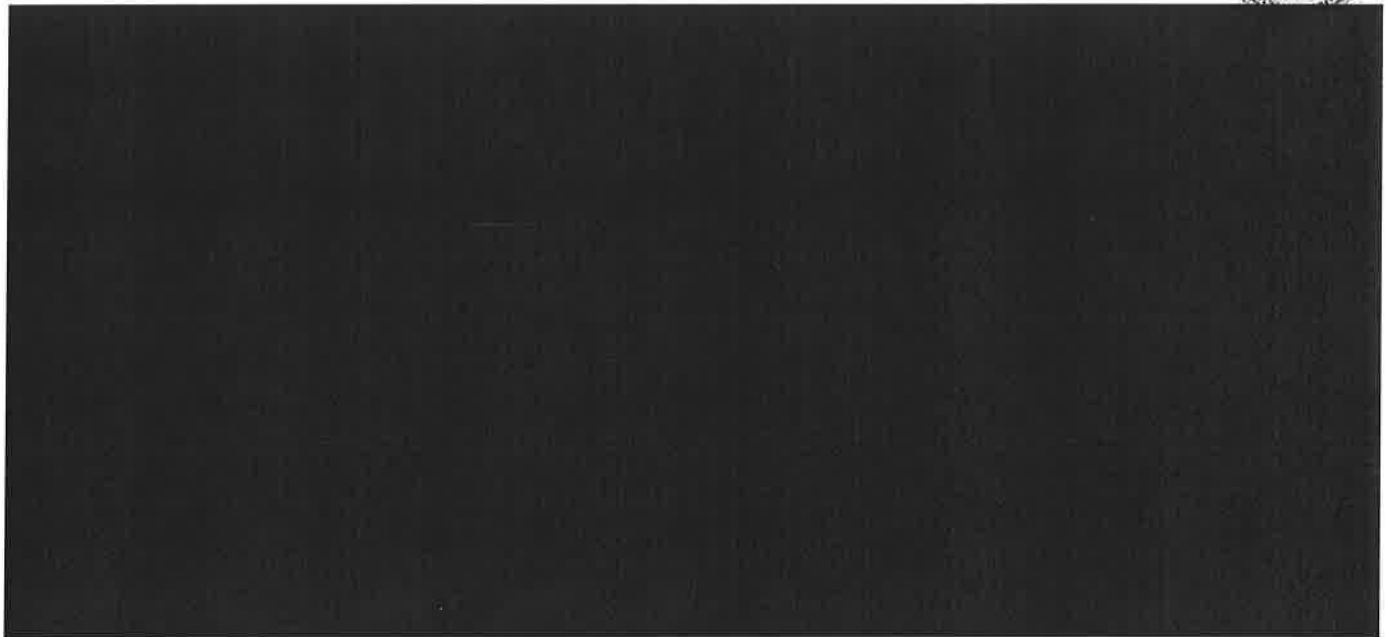

On 10 Feb 2019 in support of an aggravated battery investigation, Reporting Officer (R/O) accessed the Internet to review the on-line account(s) of persons of interest [REDACTED] 1993, IR# [REDACTED] AKA [REDACTED] and [REDACTED] 1991, IR# [REDACTED] to determine if any social media evidence exists in reference to the captioned investigation. R/O logged on to the internet through a non-attributable computer, utilizing departmental approved covert account AC0005, with the Internet Protocol (IP) address of 104.200.153.92.

R/O conducted a review of both persons of interest, previously identified Facebook (FB) accounts [REDACTED] and [REDACTED] and took screen shots of their public FB account pictures. The photo captioned below, which was posted 4 December 2015, relates to a connection between [REDACTED] and the show "Empire." A google search of "theoriginalbigdaddy" results in a verified Instagram account belonging to [REDACTED] who is credited as the co-creator, executive producer, and director of the show "Empire" who bears a strong resemblance to the man pictured below.
