The 2 fleeing individuals are laughing as they run off, southbound then westbound along river. He then looks North on New street and sees a 3rd individual. This guy keeps bending down to pick something up. Looks like he is adjusting pants leg or making snowball. He bends down about 3 or 4 times. [REDACTED] turns South to make sure the other 2 guys didn't get into the hotel. When he turns back around a few seconds later the 3rd guy is gone.
